HOUSE BILL NO. 1772

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF GENERAL FUNDS,
2 CAPITAL EXPENSE FUNDS, AND SPECIAL FUNDS FOR FISCAL YEAR 2025 TO
3 DEFRAY THE EXPENSES OF THE DEPARTMENT OF CHILD PROTECTION
4 SERVICES, THE DEPARTMENT OF HEALTH, THE OFFICE OF THE STATE
5 TREASURER, AND FOR RELATED PURPOSES

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** In addition to all other sums herein
8 appropriated, the following sum, or so much thereof as may be
9 necessary, is appropriated out of any money to the credit of the
10 General Fund, and allocated in a manner as determined by the
11 Treasurer's Office, to defray the expenses of the Department of
12 Child Protection Services for the period beginning July 1, 2024,
13 and ending June 30, 2025.....\$ 0.00.

14 This additional appropriation is for the purpose of defraying
15 out-of-state therapeutic placement expenditures.

16 **SECTION 2.** In addition to all other sums herein
17 appropriated, the following sum, or so much thereof as may be
18 necessary, is appropriated out of any money to the credit of the
19 General Fund, and allocated in a manner as determined by the



20 Treasurer's Office, to defray the expenses of the Department of
21 Child Protection Services for the period beginning July 1, 2024,
22 and ending June 30, 2025.....\$ 0.00.

23 This additional appropriation is for the purpose of defraying
24 operational expenditures due to the increased number of children
25 in custody and in-home cases.

26 **SECTION 3.** In addition to all other sums herein
27 appropriated, the following sum, or so much thereof as may be
28 necessary, is appropriated out of any money to the credit of the
29 General Fund, and allocated in a manner as determined by the
30 Treasurer's Office, to defray the expenses of the Department of
31 Child Protection Services for the period beginning July 1, 2024,
32 and ending June 30, 2025.....\$ 0.00.

33 This additional appropriation is for the purpose of defraying
34 temporary placement expenditures.

35 **SECTION 4.** In addition to all other sums herein
36 appropriated, the following sum, or so much thereof as may be
37 necessary, is appropriated out of any money to the credit of the
38 Capital Expense Fund, and allocated in a manner as determined by
39 the Treasurer's Office, to defray the expenses of the Mississippi
40 State Department of Health for the period beginning July 1, 2024
41 and ending June 30, 2025.....\$ 0.00.

42 This additional appropriation is for the purpose of defraying
43 legal expenses associated with the City of Jackson Water
44 litigation.



45 **SECTION 5.** In addition to all other sums herein
46 appropriated, the following sum, or so much thereof as may be
47 necessary, is appropriated out of any money to the credit of the
48 Abandoned Property Fund, and allocated in a manner as determined
49 by the Treasurer's Office, to defray the expenses of the Office of
50 the State Treasurer for the period beginning July 1, 2024, and
51 ending June 30, 2025.....\$ 163,000.00.

52 This additional appropriation is for the purpose of defraying
53 the expenses associated with the unclaimed property data match
54 project.

55 **SECTION 6.** This act shall take effect and be in force from
56 and after July 1, 2025.
