HOUSE CONCURRENT RESOLUTION NO. 70

1 A CONCURRENT RESOLUTION TO EXTEND THE 2025 REGULAR SESSION OF
2 THE LEGISLATURE; TO SUSPEND THE DEADLINES FOR THE PURPOSE OF
3 PERMITTING THE FURTHER CONSIDERATION, FILING AND ADOPTION OF
4 CONFERENCE REPORTS ON ANY APPROPRIATION BILLS THAT WERE IN
5 CONFERENCE ON MARCH 28, 2025, ON HOUSE BILL NOS. 1126 and 1127,
6 2025 REGULAR SESSION, AND ON SENATE BILL NOS. 2146, 2840 and 3095,
7 2025 REGULAR SESSION; TO SET THE DATE OF SINE DIE ADJOURNMENT OF
8 THE 2025 REGULAR SESSION OF THE LEGISLATURE ON FRIDAY, APRIL 11,
9 2025; AND TO PROVIDE THAT THIS RESOLUTION SHALL BE REPEALED AND OF
10 NO FORCE OR EFFECT IF THE RESOLUTION IS NOT FINALLY ADOPTED IN THE
11 SENATE BY 5:00 P.M. ON WEDNESDAY APRIL 2, 2025.

12 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
13 OF MISSISSIPPI, THE SENATE CONCURRING THEREIN, That the 2025
14 Regular Session of the Legislature is extended for a period of
15 thirty (30) days from the final day of the ninety (90) calendar
16 days of the 2025 Regular Session of the Legislature, under the
17 provisions of Section 36, Mississippi Constitution of 1890.

18 BE IT FURTHER RESOLVED, That all of the deadlines and other
19 provisions imposed by Joint Rule No. 40, are suspended for the
20 purpose of permitting the further consideration, filing and
21 adoption of conference reports, after the deadlines for those
22 actions in Joint Rule No. 40, on all of the following bills:



23 (a) Any appropriation bills that were in conference on
24 March 28, 2025, for the purpose of enacting a budget for the State
25 of Mississippi for fiscal year 2026;

26 (b) House Bill Nos. 1126 and 1127, 2025 Regular
27 Session, and Senate Bill Nos. 2146 and 2840, 2025 Regular Session;
28 and

29 (c) Senate Bill No. 3095, 2025 Regular Session, for the
30 purposes outlined in the bill and in the House amendment to the
31 bill, including, but not limited to, providing for the long-term
32 sustainability and viability of the Public Employees' Retirement
33 System and establishing a continuous, dedicated stream of revenue
34 for the Public Employees' Retirement System to help reduce the
35 current unfunded liability of the retirement system.

36 Appropriation bills are those bills that are designated as
37 appropriation bills for the purpose of the deadlines imposed by
38 Joint Rule No. 40.

39 BE IT FURTHER RESOLVED, That the 2025 Regular Session of the
40 Legislature will stand adjourned Sine Die at 11:59 p.m. CDT on
41 Friday, April 11, 2025.

42 BE IT FURTHER RESOLVED, That this resolution shall be
43 repealed and of no force or effect if the resolution is not
44 finally adopted in the Senate by 5:00 p.m. CDT on Wednesday, April
45 2, 2025.
