- A RESOLUTION TO AMEND HOUSE RULES TO CREATE A NEW HOUSE RULE
- 2 NO. 104C TO REQUIRE ANY COMMITTEE THAT PASSES SUFFRAGE BILLS TO
- 3 POST A LIST OF FACTORS USED TO DETERMINE PASSAGE OF SUFFRAGE BILLS
- 4 ON THE OFFICIAL WEBSITE OF THE MISSISSIPPI HOUSE OF
- 5 REPRESENTATIVES.
- 6 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE
- 7 OF MISSISSIPPI, That a new House Rule 104C is created to read as
- 8 follows:
- 9 104C. (1) Each House committee that considers a suffrage
- 10 bill shall establish and post a list of factors and/or criteria
- 11 used by the committee to determine which suffrage bills will be
- 12 taken up by the committee.
- 13 (2) To ensure a process that is fair and accessible, the
- 14 requirements for suffrage bill passage shall be comprised only of
- 15 objective factors and/or criteria, the satisfaction of which can
- 16 be established by means that are not overly burdensome or costly
- 17 to acquire. If an applicant satisfies the criteria, his or her
- 18 suffrage bill will move forward, with no additional opportunity or
- 19 requirement for inquiry.

- 21 (a) The person was in fact convicted of a
- 22 disenfranchising crime. A list of disenfranchising offenses
- 23 including the supplemental list of disenfranching crimes created
- 24 by the State Attorney General's office, shall be included in the
- 25 publicly-listed criteria for suffrage bills.
- 26 (b) The person has either:
- 27 (i) Completed the term and conditions of his or
- 28 her sentence for the disenfranchising crime, including probation
- 29 or parole; or
- 30 (ii) He or she has not been incarcerated in a
- 31 state prison in the last five (5) years.
- 32 (4) The factors and/or criteria shall be published on the
- 33 official website of the Mississippi House of Representatives.
- 34 BE IT FURTHER RESOLVED, That this amendment to create House
- 35 Rule 104C as contained in this resolution shall take effect
- 36 immediately upon adoption of this resolution by the House of
- 37 Representatives.
