- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** Section 99-19-75, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 99-19-75. (1) In addition to any monetary penalties and any
- 9 other penalties imposed by law, there shall be imposed and
- 10 collected from each person upon whom a court imposes a fine or
- other penalty for any violation of Section 97-3-65, 97-5-1 et seg.
- 12 or 97-3-7, when committed against a minor, an assessment of One
- 13 Thousand Dollars (\$1,000.00) to be deposited into the Mississippi
- 14 Children's Trust Fund created in Section 93-21-305, using the
- 15 procedures described in Section 99-19-73.

- 31 **SECTION 2.** This act shall take effect and be in force from
- 32 and after July 1, 2025.
