## SENATE BILL NO. 2280

1 AN ACT TO IMPOSE THE REQUIREMENT OF PROCURING A WILD TURKEY  
2 STAMP BEFORE HUNTING WILD TURKEYS IN THE STATE OF MISSISSIPPI; TO  
3 PROVIDE EXEMPTIONS FROM THE REQUIREMENT; TO ESTABLISH THE FEE FOR  
4 RESIDENT AND NONRESIDENT HUNTERS; TO PROVIDE FOR THE FURNISHING OF  
5 THE STAMP; TO SET PENALTIES FOR VIOLATIONS; TO PROVIDE THAT ALL  
6 REVENUE FROM THE PROCEEDS OF STAMPS SHALL BE DEPOSITED INTO THE  
7 FISHERIES AND WILDLIFE FUND, AND TO PROVIDE THE OBJECTIVES FOR  
8 WHICH SUCH REVENUE MAY BE USED AND EXPENDED; TO AUTHORIZE THE  
9 COMMISSION ON WILDLIFE, FISHERIES AND PARKS TO ENTER INTO  
10 AGREEMENTS WITH OTHER STATE, FEDERAL OR NONGOVERNMENTAL ENTITIES  
11 TO EXECUTE SUCH OBJECTIVES; AND FOR RELATED PURPOSES.

12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

13 **SECTION 1.** (1) For the purposes of this section, the  
14 following words and phrases shall have the meanings ascribed  
15 herein unless the context clearly indicates otherwise:

16 (a) "Wild turkey" means the game bird Meleagris  
17 gallopavo.

18 (b) "Stamp" means the state wild turkey stamp, either  
19 in its physical or electronic form, furnished by the commission.  
20 A stamp is a specialized permit required for hunting wild turkeys,  
21 with proceeds directly dispersed into the conservation,  
22 management, protection or scientific research of wild turkeys.



23           (c) "Harvest tag" means the electronic tool used to  
24   serve as an inventory of the annual bag limit allotted to  
25   individual wild turkey hunters. Harvest tags are invalidated upon  
26   the harvest of a wild turkey.

27           (d) "Nongovernmental entity" means a nonprofit  
28   organization primarily concerned with the protection and  
29   conservation of land and natural resources, as evidenced by its  
30   organizational documents.

31           (2) (a) It shall be unlawful for any person not exempt  
32   under paragraph (b) of this subsection to hunt or take wild  
33   turkeys during any open wild turkey season in this state without  
34   first having procured a stamp. The electronic stamp on file with  
35   the commission shall serve as proof of procurement.

36           (b) Any resident citizen of this state who has not  
37   reached the age of sixteen (16) years or who has reached the age  
38   of sixty-five (65) years, or any resident citizen who is blind,  
39   paraplegic or a multiple amputee, or who has been adjudged by the  
40   Veterans Administration as having a total service-connected  
41   disability, or has been adjudged to be totally disabled by the  
42   Social Security Administration shall be exempt from the  
43   requirements of this section. Further, the holder of any lifetime  
44   sportsman license authorized under Section 49-7-153 shall be  
45   exempt from the requirements of this section.

46           (3) The fee to resident hunters for each stamp shall be Ten  
47   Dollars (\$10.00). The fee to nonresident hunters for each stamp



shall be One Hundred Dollars (\$100.00). Each stamp shall be valid through the final day of the spring wild turkey season following its purchase. After its expiration, another stamp must be procured in order to hunt or take wild turkeys in a future open wild turkey season.

(4) Except for persons exempted under subsection (2)(b) of this section, the commission may make the procurement of harvest tags dependent upon the purchase of a stamp.

(5) The commission shall determine the form of the stamp. The commission shall furnish physical stamps to bonded agents for issuance or sale in the same manner as other types of licenses or shall cause the electronic stamp to accrue to the purchaser's benefit when purchased from an automated point-of-sale source.

(6) Any person violating any of the provisions of this section shall be guilty of a misdemeanor and, upon conviction, shall be fined not less than Twenty-five Dollars (\$25.00) nor more than One Hundred Dollars (\$100.00) as prescribed in Section 49-7-101.

(7) All revenue from the proceeds of stamps shall be deposited into the Fisheries and Wildlife Fund created in Section 49-5-21 and shall be used and expended only for the following objectives:

(a) Paying administrative or processing costs associated with an electronic harvest tag program, or any other program governing or regulating the harvest of wild turkeys;



73 (b) Restoring, enhancing or protecting wild turkey  
74 populations or their habitats on public or private lands in  
75 Mississippi as prescribed by the department;

76 (c) Funding scientific research, as conducted by  
77 qualified professionals, into the ecology or management of wild  
78 turkeys, their habitats or their predators; and

79 (d) Increasing access to publicly available turkey  
80 hunting opportunities.

81 (8) Proceeds from stamps may be used as matching funds or  
82 fiscal leverage to secure grants or other financial awards which  
83 are deemed to align with the objectives in subsection (7) of this  
84 section. No such proceeds shall be expended for administrative  
85 salaries.

86 (9) The commission may enter into agreements with other  
87 state, federal or nongovernmental entities to execute the  
88 objectives in subsection (7) of this section.

89 **SECTION 2.** Section 1 of this act shall be codified as a new  
90 section in Title 49, Chapter 7, Mississippi Code of 1972.

91 **SECTION 3.** This act shall take effect and be in force from  
92 and after July 1, 2025.
