1 AN ACT TO CREATE THE "TASK FORCE TO STUDY WORK FORCE AND 2 SOCIAL SERVICE REFORM AND IMPLEMENTATION OF A ONE DOOR POLICY"; TO 3 LIST THE MEMBERS OF THE TASK FORCE; TO PROVIDE FOR MEETINGS AND RESPONSIBILITIES OF THE TASK FORCE; TO ALLOW THE TASK FORCE TO 5 REQUEST THE HELP OF THE OFFICE OF WORKFORCE DEVELOPMENT; TO 6 REQUIRE THE TASK FORCE TO DRAFT A REPORT AND PRESENT IT TO THE 7 LEGISLATURE; TO PROVIDE FOR DISSOLUTION OF THE TASK FORCE; AND FOR 8 RELATED PURPOSES. 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 10 SECTION 1. (1) There is hereby established the "Task Force 11 to Study Work Force and Social Service Reform and Implementation 12 of a One Door Policy" to develop a recommendation to the 13 Legislature relative to increasing the labor force participation 14 rate in the State of Mississippi, as well as raising the earning capacity of working Mississippians through training and education 15 16 for high wage, high demand, priority sector jobs in the state. 17 The members of the task force shall be as follows: (2) The Executive Director of the Office of Workforce 18 (a) 19 Development (Accelerate MS), or his or her designee; 20 The Chairman of the Economic and Workforce 21 Development Committee of the Mississippi State Senate and the

- 24 (c) Two (2) appointments from the Governor, two (2)
- 25 appointments from the Lieutenant Governor, two (2) appointments

- 72 Development Committee and the Chairman of the House Committee on
- 73 Workforce Development shall serve as co-chairmen of the task
- 74 force. The task force shall develop and report its findings and
- 75 recommendations for proposed legislation to the Legislature on or
- 76 before December 1, 2025. A quorum of the membership shall be
- 77 required to approve any final report and recommendation. Members
- 78 of the task force shall be reimbursed for necessary travel expense
- 79 in the same manner as public employees are reimbursed for official
- 80 duties from any available funds, and members of the Legislature
- 81 shall be reimbursed in the same manner as for attending
- 82 out-of-session committee meetings.
- 83 (6) The Office of Workforce Development (Accelerate MS)
- 84 shall provide necessary clerical assistance for meetings of the
- 85 task force and the preparation of the report. Proposed
- 86 legislation shall be prepared by the Legislative Services Offices
- 87 of the Senate and House as requested.
- 88 (7) The task force shall be dissolved upon presentation of
- 89 its report.
- 90 **SECTION 2.** This act shall take effect and be in force from
- 91 and after its passage, or effective date of the reauthorized
- 92 federal Workforce and Innovation Opportunity Act, should that act
- 93 create new opportunities for pilot comprehensive innovation
- 94 demonstration programs under which Mississippi qualifies,
- 95 whichever date is sooner.
