5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. Section 25-7-13, Mississippi Code of 1972, is
7	amended as follows:
8	25-7-13. (1) The clerks of the circuit court shall charge
9	the following fees:
10	(a) Docketing, filing, marking and registering each
11	complaint, petition and indictment\$ 85.00
12	The fee set forth in this paragraph shall be the total fee
13	for all services performed by the clerk up to and including entry
14	of judgment with respect to each complaint, petition or
15	indictment, including all answers, claims, orders, continuances
16	and other papers filed therein, issuing each writ, summons,
17	subpoena or other such instruments, swearing witnesses, taking and
18	recording bonds and pleas, and recording judgments, orders, fiats

28	(c) For every civil case filed, an additional fee to be

34	(3) On order of the court, clerks and deputies may be
35	allowed five (5) extra days for attendance upon the court to get

37	(4) The clerk's fees in state cases where the state fails in
88	the prosecution, or in cases of felony where the defendant is
39	convicted and the cost cannot be made out of his or her estate, in
90	an amount not to exceed Four Hundred Dollars (\$400.00) in one (1)
91	year, shall be paid out of the county treasury on approval of the
92	circuit court, and the allowance thereof by the board of
93	supervisors of the county. In counties having two (2) judicial
94	districts, such allowance shall be made in each judicial district;

- one-half of one percent (1/2 of 1%) on all such sums.
- 106 (6) For making final records required by law, including, but
- 107 not limited to, circuit and county court minutes, and furnishing
- 108 transcripts of records, the circuit clerk shall charge Two Dollars
- 109 (\$2.00) per page. The same fees shall be allowed to all officers

- 112 (7) The circuit clerk shall prepare an itemized statement of
- 113 fees for services performed, cost incurred, or for furnishing
- 114 copies of any papers of record or on file, and shall submit the
- 115 statement to the parties or, if represented, to their attorneys
- 116 within sixty (60) days. A bill for same shall accompany the
- 117 statement.
