SENATE BILL NO. 2622

- AN ACT TO AMEND SECTION 37-73-7, MISSISSIPPI CODE OF 1972, TO REVISE THE STATE WORKFORCE INVESTMENT BOARD'S LIST OF NATIONALLY RECOGNIZED INDUSTRY CERTIFICATIONS TO ENSURE REIMBURSEMENT FUNDS APPLY ONLY TO CERTAIN PRIORITY SECTORS; TO BRING FORWARD SECTION 37-153-15, MISSISSIPPI CODE OF 1972, WHICH PROVIDES FOR CERTAIN GRANT FUNDS, FOR THE PURPOSE OF POSSIBLE AMENDMENT; AND FOR RELATED PURPOSES.
- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** Section 37-73-7, Mississippi Code of 1972, is
- 10 amended as follows:
- 11 37-73-7. The State Workforce Investment Board, by and
- 12 through the Office of Workforce Development, shall create, in
- 13 consultation with the Mississippi Department of Education, the
- 14 Mississippi Community College Board, the Mississippi State
- 15 University Research and Curriculum Unit and other appropriate
- 16 business and industry stakeholders, a single list of nationally
- 17 recognized industry certifications * * * for reimbursement under
- 18 Section 37-153-15.
- 19 SECTION 2. Section 37-153-15, Mississippi Code of 1972, is
- 20 brought forward as follows:

- 22 (a) The words "industry certification" mean a process
- 23 through which students are assessed by an independent, third-party
- 24 certifying entity using predetermined standards for knowledge,
- 25 skills and competencies, resulting in the award of a credential
- 26 that is nationally recognized and must be at least one (1) of the
- 27 following:
- 28 (i) Within an industry that addresses a critical
- 29 local, regional or statewide economic need;
- 30 (ii) Linked to an occupation that is included in
- 31 the State Department of Employment Security's occupations in
- 32 high-demand list; or
- 33 (iii) Linked to an occupation that is identified
- 34 as emerging.
- 35 (b) The words "qualifying industry certification" mean
- 36 an industry certification that is linked to an occupation with
- 37 wages of at least seventy percent (70%) of the median state income
- 38 unless the industry certification is stackable to another
- 39 postsecondary or professional credential which is linked to an
- 40 occupation which meets the wage criterion.
- 41 (2) The State Workforce Investment Board shall provide the
- 42 State Board of Education annually with a list of qualifying
- 43 industry certifications. If the occupations identified in the
- 44 list are not substantially the same as those occupations

- identified in the prior year, the State Board of Education shall provide reasonable notice of the changes to school districts.
- 47 Beginning in fiscal year 2019-2020 and subject to available funding, the Department of Education shall pay a career 48 49 and technical education incentive grant to the public school for 50 each student enrolled in the public school who earns a qualifying industry certification. The amount per student for the career and 51 52 technical education incentive grant shall be Six Hundred Dollars 53 (\$600.00). If the statewide sum of the career and technical 54 education incentive grants awarded pursuant to this section 55 exceeds the amount of available funds appropriated for the grants, 56 the grants per student shall be reduced proportionately to cover all eligible grants under this section. Any costs accrued during 57 one (1) fiscal year may be claimed and reimbursed in the following 58 59 fiscal year.
- 60 The grants may be used for qualifying industry 61 certification examination fees, professional development for teachers in career and technical education programs under this 62 63 section, student instructional support for programs that lead to 64 qualifying industry certifications, or to increase access to 65 qualifying industry certifications. Any grants awarded under this 66 section may not be used to supplant funds provided for the basic operation of the career and technical education programs. 67
- 68 (5) On or before October 1 of each year, the Department of 69 Education, working in collaboration with the Office of Workforce

- 70 Development and any other entities as necessary, shall submit a
- 71 report to the Governor, the Lieutenant Governor, the Speaker of
- 72 the House of Representatives, the Chairmen of the House and Senate
- 73 Education Committees, the Chairman of the House Workforce
- 74 Development Committee and the Chairman of the Senate Economic and
- 75 Workforce Development Committee on the following:
- 76 (a) The number of students who enrolled in a career and
- 77 technical education course or program that leads to a qualifying
- 78 industry certification.
- 79 (b) The number of students who earned a qualifying
- 80 industry certification by certification.
- 81 (c) The amount of career and technical education
- 82 incentive grants awarded by the school.
- 83 (d) The amount of career and technical education
- 84 incentive grants awarded per student.
- 85 (e) Aggregated demographic data on the students who
- 86 earned a qualifying industry certification, including the
- 87 qualifying industry certifications earned by rural and urban
- 88 students.
- 89 **SECTION 3.** This act shall take effect and be in force from
- 90 and after July 1, 2025.
