responder families, or both, to provide marriage counseling,

is authorized to implement policies to award such grants and is

- 24 (2) For purposes of this section, the following terms shall
- 25 have the meaning ascribed herein:
- 26 (a) "Military" means the Armed Forces or Reserves of
- 27 the United States, including the Army, Navy, Marine Corps, Coast
- 28 Guard, Air Force and the reserve components thereof, the National
- 29 Guard of any state, the military reserves of any state or the
- 30 naval militia of any state.
- 31 (b) "First responder" means those serving as a:
- 32 (i) Firefighter;
- 33 (ii) Emergency medical technician;
- 34 (iii) Rescue squad member;
- 35 (iv) Law enforcement officer;
- 36 (v) Correctional officer; or
- 37 (vi) Sworn member of the State Fire Marshal's
- 38 Office.
- 39 (c) "Non-profit" means an entity described in Section
- 40 501(c)(3) of the Internal Revenue Code.
- 41 (3) It is the intent of the Legislature that funding
- 42 authorized under this section be used to supplement, not supplant,
- 43 other sources of revenue heretofore or hereafter used for the
- 44 purposes of this section.
- 45 **SECTION 2.** This act shall take effect and be in force from
- 46 and after July 1, 2025.
