- 22 Manager of Mercedes-Benz of Daytona Beach, Florida, in 1994; and
- 23 WHEREAS, Trudy became Dealer Principal of Mercedes-Benz of
- 24 Jackson in 2001 when the family bought the dealership; and
- 25 WHEREAS, Trudy has played a major role in Mercedes-Benz of
- 26 Collierville in Collierville, Tennessee, and Tidelands Ford in
- 27 Pawleys Island, South Carolina, owned by the family-owned
- 28 Higginbotham Automotives; and
- 29 WHEREAS, Trudy is an active member of the Mississippi
- 30 Automobile Dealers Association and has served in several
- 31 leadership positions, including Chair in 2024, Vice Chair in 2023,
- 32 and Secretary in 2022. Under her leadership, this organization
- 33 has become one of the most powerful and influential lobbying
- 34 groups in Mississippi; and
- 35 WHEREAS, Moody is focused on creating and fostering business
- 36 opportunities in her region. She has served on The Mercedes-Benz
- 37 Dealer Board after being elected by her peers; and
- 38 WHEREAS, Moody is proud to support a variety of fundraisers,

- 40 is with the Batson Children's Hospital at the University of
- 41 Mississippi Medical Center, for which she is also a member of the
