## SENATE RESOLUTION NO. 125

1 A RESOLUTION COMMEMORATING THE 50TH ANNIVERSARY OF THE  
2 MISSISSIPPI STATE FIRE ACADEMY AND RECOGNIZING ITS IMPACT ON FIRE  
3 SERVICE TRAINING AND PUBLIC SAFETY IN MISSISSIPPI.

4 WHEREAS, we join the leadership, instructors, support staff,  
5 graduates and citizens of Mississippi in honoring the Mississippi  
6 State Fire Academy on the occasion of its 50th Anniversary; and

7 WHEREAS, since its establishment in 1974, the Mississippi  
8 State Fire Academy has been the premier institution for fire  
9 service training in the state, preparing generations of  
10 firefighters to protect lives and property through rigorous,  
11 high-quality instruction; and

12 WHEREAS, the Academy has continually evolved to meet the  
13 changing demands of fire service, incorporating advanced training  
14 techniques, modern firefighting technologies and national best  
15 practices to ensure that Mississippi's firefighters remain among
