## House Amendments to Senate Bill No. 3003

## TO THE SECRETARY OF THE SENATE:

THIS IS TO INFORM YOU THAT THE HOUSE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

7 SECTION 1. The following sums of money, or so much thereof 8 as may be necessary, are hereby appropriated out of any money in 9 the State General Fund not otherwise appropriated, to the Board of 10 Trustees of State Institutions of Higher Learning for the purpose 11 of support of the Center for Advanced Vehicular Systems, Center 12 for Manufacturing Excellence, Mississippi State Chemical 13 Laboratory, Water Resources Institute, Mississippi Law Research 14 Institute, Jackson State University Urban Research Center, 15 Mississippi Mineral Resources Research Institute, Research 16 Institute of Pharmaceutical Sciences, the Supercomputer, the 17 Stennis Institute of Government, Gulf Coast Research Laboratory, 18 Polymer Institute, Small Business Development Center, Stennis 19 Center for Higher Learning, the Commission for Volunteer Services, 20 the State Court Education Program, and the executive office of the 21 board of trustees for the fiscal year beginning July 1, 2025, and 22 ending June 30, 2026.....\$ 39,622,232.00.

Of the funds appropriated under the provisions of Section 1

103 of this act and allocated to the Gulf Coast Research Laboratory,

104 the Board of Trustees of State Institutions of Higher Learning

106 (\$175,000.00) for Sea Grants matching for the Fiscal Year 2026.

107 Provided further, it is the intention of the Legislature, in

108 the event budget reductions are imposed on the Gulf Coast Research

109 Laboratory by the Board of Trustees of State Institutions of

110 Higher Learning, as a result of the Governor ordering budget

reductions under the provisions of Section 27-104-13 or 31-17-123,

112 Mississippi Code of 1972, the same percent reduction will be

applied to those state funds identified in this section for Sea

It is the intent of the Legislature that no general funds
authorized to be expended herein shall be used to replace federal
funds and/or other special funds which are being used for salaries
authorized under the provisions of this act and which are

119 withdrawn and no longer available.

After the Mississippi State Chemical Laboratory has provided the maximum amount of services which may be provided free of charge under the provisions of Section 57-21-11(c), Mississippi Code of 1972, the laboratory shall not provide any additional services from the funds appropriated under the provisions of Sections 1 and 2 of this act if any charges for such services previously provided are more than ninety (90) days past due.

- 127 After all such delinquent charges have been paid by a client, the
- 128 laboratory may provide additional services to the client.
- 129 **SECTION 4.** Of the funds appropriated in Section 2 of this
- 130 act and authorized for expenditure in Section 3(b) of this act,

- 140 **SECTION 5.** None of the funds appropriated by this act shall
- 141 be expended for any purpose that is not actually required or
- 142 necessary for performing any of the powers or duties of the Board
- 143 of Trustees of State Institutions of Higher Learning, or any of
- 144 the powers or duties of any institution under the jurisdiction of
- 145 the board of trustees, that are authorized by the Mississippi
- 146 Constitution of 1890, state or federal law, or rules or
- 147 regulations that implement state or federal law.
- 148 **SECTION 6.** It is the intention of the Legislature that the
- 149 budget requests of the individual institutes, laboratories and
- 150 programs consolidated in this bill for Fiscal Year 2027 shall be
- 151 submitted to the Joint Legislative Budget Committee in a format

- 152 and level of detail comparable to the format and level of detail
- 153 provided during the Fiscal Year 2026 budget request process.
- 154 **SECTION 7.** The Board of Trustees of State Institutions of
- 155 Higher Learning shall report yearly to the Legislature any
- 156 institution not in compliance with Section 97-11-51, Mississippi
- 157 Code of 1972, which prohibits deficit spending.
- 158 **SECTION 8.** Any funds appropriated pursuant to this act and
- 159 paid as a fee to or deposited in a financial institution shall be
- 160 in compliance with Section 109 of the Constitution of the State of
- 161 Mississippi and Section 25-4-105, Mississippi Code of 1972.
- 162 **SECTION 9.** It is the intention of the Legislature that
- 163 whenever two (2) or more bids are received by this agency for the
- 164 purchase of commodities or equipment, and whenever all things
- 165 stated in such received bids are equal with respect to price,
- 166 quality and service, the Mississippi Industries for the Blind
- 167 shall be given preference. A similar preference shall be given to
- 168 the Mississippi Industries for the Blind whenever purchases are
- 169 made without competitive bids.
- 170 **SECTION 10.** None of the funds appropriated and/or authorized
- 171 for expenditure under this act shall be used for research in which
- 172 a human embryo is killed or destroyed.
- 173 **SECTION 11.** It is the intention of the Legislature that the
- 174 funds herein appropriated shall be expended in compliance with
- 175 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 176 shall incur obligations or indebtedness in excess of their
- 177 appropriation and that the responsible officers, either personally

or upon their official bonds, shall be held responsible for actions contrary to this provision.

SECTION 12. Of the funds appropriated in Section 1 of this act, One Million Five Hundred Thousand Dollars (\$1,500,000.00) is hereby provided for the National Center for Cannabis Research and Education at the University of Mississippi - Research Institute of Pharmaceutical Sciences for the purpose of data analysis, educational initiatives, and other activities in collaboration with the State Department of Health pursuant to Section 41-138-1, Mississippi Code of 1972. 

SECTION 13. The following sum, or so much thereof as may be necessary, is reappropriated out of any money in the Capital Expense Fund not otherwise appropriated for the Executive Office of the Board of Trustees for the purpose of reauthorizing the expenditure of Capital Expense Fund, as appropriated in SB 3007, 2024 Regular Session, for the repair, maintenance, or replacement of the fire detection and suppression system at the IHL Education and Research Center for the fiscal year beginning July 1, 2025, and ending June 30, 2026..........\$ 300,000.00.

Notwithstanding the amount reappropriated under this section, the amount that may be expended under the authority of this section shall not exceed the unexpended balance of the funds remaining as of June 30, 2025, from the amount authorized for the previous fiscal year. In addition, this reappropriation shall not change the purpose for which the funds were originally authorized.

SECTION 14. The money herein appropriated shall be paid by the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers, in the manner provided by law.

SECTION 15. This act shall take effect and be in force from and after July 1, 2025.
