20 With the funds herein appropriated, it shall be the agency's 21 responsibility to make certain that funds required for Personal 22 Services for Fiscal Year 2027 do not exceed Fiscal Year 2026 funds 23 appropriated for that purpose unless programs or positions are 24 added to the agency's Fiscal Year 2026 budget by the Mississippi 25 Legislature. The Legislature shall determine the agency's personal services appropriation, which the State Personnel Board 26 The agency's personal services appropriation may 27 shall publish. 28 consist of restricted funds for approved vacancies for Fiscal Year 29 2026 that may be utilized to fill vacant Fiscal Year 2025 30 headcount. 276	2027 shall be submitted to the Joint Legislative Budget Committee	
277	in a format and level of detail comparable to the format and level	

- of detail provided during the Fiscal Year 2026 budget request process.
- SECTION 12. Of the funds appropriated under the provisions
 of Section 2 of this act, funds may be expended to defray the
 costs of clothing for sworn nonuniform law enforcement officers in
 an amount not to exceed One Thousand Dollars (\$1,000.00) annually
 per officer.
- 285 SECTION 13. It is the intention of the Legislature that 286 whenever two (2) or more bids are received by this agency for the 287 purchase of commodities or equipment, and whenever all things 288 stated in such received bids are equal with respect to price, 289 quality and service, the Mississippi Industries for the Blind 290 shall be given preference. A similar preference shall be given to 291 the Mississippi Industries for the Blind whenever purchases are 292 made without competitive bids.
- SECTION 14. The department is authorized to expend available funds on technology or equipment upgrades or replacements when it will generate savings through efficiency or when the savings generated from such upgrades or replacements exceed expenditures thereof.
- SECTION 15. Of the funds provided herein, and in addition to the One Hundred Dollars (\$100.00) authorized in Section 45-3-7, Mississippi Code of 1972, Department of Public Safety Officers who are licensed commercial pilots shall receive an additional Nine Hundred Dollars (\$900.00), for a total of One Thousand Dollars (\$1,000.00), additional compensation for such service.

304 SECTION 16. It is the intention of the Legislature that the 305 Department of Public Safety shall provide an annual report to the 306 Mississippi Legislature detailing any elected official or any 307 other person who is not an employee of the Department of Public 308 Safety who was transported in Highway Patrol aircraft during the 309 fiscal year. The report shall be provided to each member of the 310 Mississippi Legislature on or before January 15, 2026. SECTION 17. The Commissioner of Public Safety shall have the 311 312 authority to transfer any funds from any division within the Department of Public Safety to any other division of the 313 Department of Public Safety Special Funds, including, but not 314 limited to, Funds 3711, 371C, 371E, 3713, 3714, 3715, 3740, 3741, 315 3742, 3744, 3747 and 3718, not to exceed Twenty Million Dollars 316 317 (\$20,000,000.00) collectively during Fiscal Year 2026. However, 318 none of the funds appropriated by this act shall be expended 319 unless the Department of Public Safety provides prior written 320 notification of any transfer of funds provided in this section. 321 SECTION 18. The Bureau of Narcotics is authorized to expend 322 a sum, not to exceed Five Hundred Thousand Dollars (\$500,000.00) from account No. 3371800000, for purposes of effectuating the 323 324 provisions of Section 41-29-179, Mississippi Code of 1972, Section 325 1 of this act. Expenditures authorized by this section may 326 include, but not be limited to, costs associated with contracting 327 with one or more vendors, contractors or other persons or entities 328 to create, operate and maintain the forfeiture website and to provide continuing support in relation thereto. In the event an 329
