20	SECTION 3. Of the funds appropriated in Section 2 of this
21	act, Seven Hundred Fifty Thousand Dollars (\$750,000.00) shall be
22	derived from the Education Enhancement Fund from funds deposited
23	pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of
24	1972.
25	SECTION 4. No general funds authorized to be expended herein
26	shall be used to replace federal funds and/or other special funds
27	which are being used for salaries authorized under the provisions
28	of this act and which are withdrawn and no longer available.
29	SECTION 5. It is the intention of the Legislature that the
30	agency's budget request for Fiscal Year 2027 shall be submitted to
31	the Joint Legislative Budget Committee in a format and level of
32	detail comparable to the format and level of detail provided
33	during the Fiscal Year 2026 budget request process.
34	SECTION 6. In compliance with the "Mississippi Performance
35	Budget and Strategic Planning Act of 1994," it is the intent of
36	the Legislature that the funds provided herein shall be utilized
37	in the most efficient and effective manner possible to achieve the
38	intended mission of this agency. Based on the funding authorized,

85	SECTION 8. It is the intention of the Legislature that	
86	whenever two (2) or more bids are received by this agency for the	
87	purchase of commodities or equipment, and whenever all things	
88	stated in such received bids are equal with respect to price,	
89	quality and service, the Mississippi Industries for the Blind	
90	shall be given preference. A similar preference shall be given to	

- 91 the Mississippi Industries for the Blind whenever purchases are
- 92 made without competitive bids.
- 93 **SECTION 9.** It is the intention of the Legislature that the
- 94 funds herein appropriated shall be expended in compliance with
- 95 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 96 shall incur obligations or indebtedness in excess of their
- 97 appropriation and that the responsible officers, either personally
- 98 or upon their official bonds, shall be held responsible for
- 99 actions contrary to this provision.
- 100 **SECTION 10.** Of the funds appropriated in Section 1 of this
- 101 act, One Hundred Twenty Thousand Dollars (\$120,000.00) is hereby
- 102 provided for scholarships for the Dr. Elton Mac Huddleston Rural
- 103 Veterinarians Scholarship Program as prescribed in Section
- 104 37-113-71, Mississippi Code of 1972.
- 105 **SECTION 11.** Of the funds in Section 2 of this act, Seventeen
- 106 Million Five Hundred Thousand Dollars (\$17,500,000.00) is provided
- 107 from the Mississippi State University Veterinary School Fund as
- 108 created in Section 37-113-55, Mississippi Code of 1972, for the
- 109 purpose of paying costs associated with the design, construction,
- 110 renovation, repairs, and equipping of the Wise Center.
- 111 **SECTION 12.** The money herein appropriated shall be paid by
- 112 the State Treasurer out of any money in the State Treasury to the
- 113 credit of the proper fund or funds as set forth in this act, upon
- 114 warrants issued by the State Fiscal Officer; and the State Fiscal



- 115 Officer shall issue his warrants upon requisitions signed by the
- 116 proper person, officer or officers in the manner provided by law.
- 117 **SECTION 13.** This act shall take effect and be in force from
- 118 and after July 1, 2025.
