It is the intention of the Legislature that the 42 Executive Department shall maintain complete accounting and personnel records related to the expenditure of all funds 43 appropriated under this act and that such records shall be in the 44 45 same format and level of detail as maintained for Fiscal Year 46 2025. It is further the intention of the Legislature that the 47 agency's budget request for Fiscal Year 2027 shall be submitted to 48 the Joint Legislative Budget Committee in a format and level of 49 detail comparable to the format and level of detail provided
- SECTION 6. The money herein appropriated shall be paid by
 the State Treasurer out of any money in the State Treasury to the
 credit of the proper fund or funds as set forth in this act, upon
 warrants issued by the State Fiscal Officer; and the State Fiscal
 Officer shall issue his warrants upon requisitions signed by the
 proper person, officer or officers, in the manner provided by law.
