

Senate Amendments to House Bill No. 1284

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

1 **AMEND** by adding the following on lines 1504, 1682, 1699, 2348
2 **and 2432 after "1972,"**:

3 as amended by Senate Bill No. 2145, 2025 Regular Session,

4 **FURTHER, AMEND** on line 1514 by inserting the following before
5 **the period:**

6 and Sections 1 through 9 of Senate Bill No. 2145, 2025 Regular
7 Session

8 **FURTHER, AMEND** on line 1693 by inserting the following after
9 **the period:**

10 The holder of a direct wine shipper's permit may sell wines
11 directly to residents in this state as authorized by Sections 1
12 through 9 of Senate Bill No. 2145, 2025 Regular Session.

13 **FURTHER, AMEND** on line 2350 by inserting the following at the
14 **beginning of the sentence:**

15 (1) Except as otherwise provided in subsection (3) of this
16 section,

17 **FURTHER, AMEND on line 2360 by inserting the following at the**
18 **beginning of the sentence:**

19 (2) Except as otherwise provided in subsection (3) of this

21 **FURTHER, AMEND by inserting the following below line 2370:**

22 (3) Information regarding the sales, shipment, delivery and
23 transportation of wine in this state by the holder of a direct
24 wine shipper's permit under Sections 1 through 9 of Senate Bill
25 No. 2145, 2025 Regular Session, shall be in such form and content
26 as prescribed by the department.

27 **FURTHER, AMEND by inserting the following below line 2491 and**
28 **renumbering the subsequent paragraph(s):**

29 (ae) Direct wine shipper's permit.....\$ 100.00

30 (af) Wine fulfillment provider's permit.....\$ 100.00

31 **FURTHER, AMEND on lines 2515-2516 by deleting "a temporary**
32 **permittee or a delivery service permittee" and inserting in lieu**
33 **thereof the following:**

34 temporary permittee, delivery service permittee or direct wine
35 shipper's permittee

36 **FURTHER, AMEND by deleting "Alcoholic Beverage Control" on**
37 **lines 1934, 1938 and 2116.**

38 **FURTHER, AMEND by deleting "of the department" on line 1935.**

39 **FURTHER, AMEND by deleting "of the Department of Revenue" on**
40 **line 2116-2117.**

41 **FURTHER, AMEND by inserting the following below line 2227 and**
42 **renumbering the subsequent paragraph(s):**

43 (x) **Direct wine shipper's permit.** A direct wine
44 shipper's permit shall authorize the holder to sell and ship a
45 limited amount of wine directly to residents in this state in
46 accordance with the provisions of Sections 1 through 9 of Senate
47 Bill No. 2145, 2025 Regular Session, without being required to
48 transact the sale and shipment of those wines through the
49 division.

50 (y) **Wine fulfillment provider's permit.** A wine
51 fulfillment provider's permit authorizes a fulfillment provider,
52 as defined in Section 1 of Senate Bill No. 2145, 2025 Regular
53 Session, to ship wine to a consumer on behalf of a holder of a
54 direct wine shipper's permit.

55 **FURTHER, AMEND the title to conform by inserting "AS AMENDED**
56 **BY SENATE BILL NO. 2145, 2025 REGULAR SESSION," in the following**
57 **places:**

58 **On line 13, after "67-1-41," and "67-1-45,"**
