Senate Amendments to House Bill No. 1474

TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 6 **SECTION 1.** Section 47-5-94, Mississippi Code of 1972, is
- 7 amended as follows:
- 8 47-5-94. The Bureau of Building, Grounds and Real Property
- 9 Management of the Department of Finance and Administration and the
- 10 State Board of Health are hereby authorized and directed, upon the
- 11 passage of this section, to institute permanent annual structural
- 12 and environmental inspections of institutional housing and service
- 13 facilities at the State Penitentiary, such inspections to include,
- 14 but not be limited to, structural soundness, repairs and
- 15 maintenance of buildings; food service; fire and safety hazards;
- 16 fresh water supply; wastewater system; sewage collection and
- 17 treatment; solid waste collection, storage and disposal; rodent
- 18 and pest control and general institutional housekeeping.
- 19 Beginning July 1, 2025, the Mississippi State Department of Health
- 20 shall conduct an annual structural and environmental inspection of
- 21 the infirmary at the State Penitentiary at Parchman and make a
- 22 report thereon as required in this section.

- 24 and departments are hereby directed, upon the request of the
- 25 Commissioner of Corrections, the Bureau of Building, Grounds and
- 26 Real Property Management of the Department of Finance and

- 29 Within thirty (30) days of the completion of the inspections
- 30 provided for herein, the participants shall compile a written
- 31 report of their findings which shall be submitted to the Governor,
- 32 the Commissioner of Corrections and the Warden or Superintendent
- 33 of the State Penitentiary at Parchman.
- 34 **SECTION 2.** This act shall take effect and be in force from
- 35 and after July 1, 2025.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO AMEND SECTION 47-5-94, MISSISSIPPI CODE OF 1972, TO AUTHORIZE AND DIRECT THE MISSISSIPPI STATE DEPARTMENT OF HEALTH TO

PERFORM AN ANNUAL INSPECTION OF THE INFIRMARY AT THE STATE

4 PENITENTIARY AT PARCHMAN; AND FOR RELATED PURPOSES.
