## Senate Amendments to House Bill No. 1555

## TO THE CLERK OF THE HOUSE:

THIS IS TO INFORM YOU THAT THE SENATE HAS ADOPTED THE AMENDMENTS SET OUT BELOW:

## AMENDMENT NO. 1

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 5 **SECTION 1.** (1) There is created the Mississippi Curriculum
- 6 Alignment Task Force to review and make recommendations on how to
- 7 align the curriculum at the secondary and post secondary levels
- 8 throughout the state.
- 9 (2) The task force shall be composed of the following
- 10 members:
- 11 (a) The Executive Director of the Mississippi Community
- 12 College Board, or his or her designee;
- 13 (b) The Superintendent of the Mississippi Department of
- 14 Education, or his or her designee;
- 15 (c) The Commissioner of the Board of Trustees of State
- 16 Institutions of Higher Learning, or his or her designee;
- 17 (d) The Executive Director of the Office of Workforce
- 18 Development, or his or her designee;
- 19 (e) Two (2) members who represent the community and
- 20 junior colleges, to be appointed by the Speaker of the House of
- 21 Representatives;

- 22 (f) Two (2) members who represent the Mississippi
- 23 Department of Education, to be appointed by the Lieutenant
- 24 Governor;
- 25 (q) Two (2) members from the Office of Workforce
- 26 Development, to be appointed by the Executive Director of the
- 27 Office of Workforce Development;
- 28 (h) The Chair of the Mississippi House of
- 29 Representatives Workforce Development Committee;
- 30 (i) The Chair of the Mississippi House of
- 31 Representatives Education Committee;
- 32 (j) The Chair of the Mississippi House of
- 33 Representatives Universities and Colleges Committee;
- 34 (k) The Chair of the Mississippi Senate Economic and
- 35 Workforce Development Committee;
- 36 (1) The Chair of the Mississippi Senate Education
- 37 Committee; and
- 38 (m) The Chair of the Mississippi Senate Universities
- 39 and Colleges Committee.
- 40 (3) The duties of the task force shall include the
- 41 following:
- 42 (a) Study the curriculum at the secondary and
- 43 post-secondary levels and determine the best ways to align those
- 44 curriculums so that the best interest of the students are met;
- 45 (b) Examine the high school experience and the
- 46 community college experience and determine what each experience
- 47 should incorporate;

- 48 (c) Analyze the Carnegie units currently required at
- 49 the secondary level and determine if those properly align with
- 50 what is best for each student enrolled in this state;
- 51 (d) Calculate the funding that would be necessary to
- 52 properly align the curriculum at the secondary and post-secondary
- 53 levels; and
- (e) Determine what state law changes are needed, if
- 55 any, to align the curriculum at the secondary and post-secondary
- 56 levels.
- 57 (4) (a) Appointments to the task force shall be made within
- 58 thirty (30) days after the effective date of this act. Within
- 59 fifteen (15) days thereafter on a day to be designated jointly by
- 60 the Speaker of the House of Representatives and the Lieutenant
- 61 Governor, the task force shall meet and organize by selecting from
- 62 its membership a chair and a vice chair. The vice chair shall
- 63 also serve as secretary and shall be responsible for keeping all
- 64 records of the task force. A majority of the members of the task
- 65 force shall constitute a quorum. In the selection of its officers
- 66 and the adoption of rules, resolutions and reports, an affirmative
- 67 vote of a majority of the task force shall be required. All
- 68 members shall be notified in writing of all meetings, and those
- 69 notices shall be mailed at least fifteen (15) days before the date
- 70 on which a meeting is to be held.
- 71 (b) The task force shall meet at least once each month
- 72 and provide monthly reports to the Legislature on its activities.

- 73 (c) The task force shall make a final report of its
- 74 findings and recommendations, including any recommended
- 75 legislation, to the Legislature not later than December 1, 2025,
- 76 at which time the task force will be dissolved.
- 77 (5) Members of the task force shall receive no compensation
- 78 for their service on the task force, but may receive reimbursement
- 79 for mileage and actual expenses as provided in Section 25-3-41, to
- 80 the extent that funds are available for that purpose.
- 81 (6) The Mississippi Department of Education shall provide
- 82 the staff and other support necessary for the task force to
- 83 perform its duties.
- 84 (7) To effectuate the purposes of this act, any department,
- 85 division, board, bureau, committee, institution or agency of the
- 86 state, or any political subdivision thereof, shall, at the request
- 87 of the chairman of the task force, provide the facilities,
- 88 assistance, information and data needed to enable the task force
- 89 to carry out its duties.
- 90 **SECTION 2.** This act shall take effect and be in force from
- 91 and after its passage, and shall stand repealed on the day before
- 92 its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT TO CREATE THE MISSISSIPPI CURRICULUM ALIGNMENT TASK FORCE; TO PROVIDE FOR THE MEMBERS OF THE TASK FORCE; TO PROVIDE THE DUTIES OF THE TASK FORCE; AND FOR RELATED PURPOSES.
