Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 23 shall publish. The agency's personal services appropriation may
- 24 consist of restricted funds for approved vacancies for Fiscal Year

- 26 headcount. It shall be the agency's responsibility to ensure that
- 27 the funds provided for vacancies are used to increase headcount
- and not for promotions, title changes, in-range salary adjustments 28

- 101 this act, and as approved by the Mississippi State Board of

- 103 Executive Director may negotiate and enter into a grant agreement
- 104 to provide funding in an amount not to exceed Six Hundred Thousand
- 105 Dollars (\$600,000.00) for the Mississippi Physician Health
- 106 Program.
- 107 **SECTION 7.** Of the funds provided under the provisions of
- 108 this act, an amount not to exceed One Hundred Thirty Thousand
- 109 Dollars (\$130,000.00) may be allocated to the Mississippi Board of
- 110 Pharmacy to defray the expense of the Mississippi Prescription
- 111 Monitoring Program.
- SECTION 8. Of the funds appropriated in Section 1, Twenty
- 113 Thousand Dollars (\$20,000.00) is provided for computer repairs,
- 114 replacement, and upgrades.
- 115 **SECTION 9.** It is the intention of the Legislature that the
- 116 funds are appropriated here in accordance with a signed Memorandum
- 117 of Understanding with the Mississippi Department of Health to
- 118 assist with the implementation of the Medical Cannabis Act for
- 119 registering and monitoring compliance with the rules and
- 120 regulations of the Act.
- 121 **SECTION 10.** It is the intention of the Legislature that, for
- 122 Fiscal Year 2026, the board shall be allowed to recover all costs
- 123 from a holder of a license who has been found by the board in
- 124 violation of statute after notice and a hearing as provided by
- 125 law. The expenses must be direct costs associated with the

- 126 investigation and conduct of a proceeding for licensure
- 127 revocation, suspension or restriction.
- 128 **SECTION 11.** It is the intention of the Legislature that the
- 129 funds herein appropriated shall be expended in compliance with
- 130 Section 27-104-25, Mississippi Code of 1972, that no state agency
- 131 shall incur obligations or indebtedness in excess of their
- 132 appropriation and that the responsible officers, either personally
- 133 or upon their official bonds, shall be held responsible for
- 134 actions contrary to this provision.
- 135 **SECTION 12.** The money herein appropriated shall be paid by
- 136 the State Treasurer out of any money in the State Treasury to the
- 137 credit of the proper fund or funds as set forth in this act, upon
- 138 warrants issued by the State Fiscal Officer; and the State Fiscal
- 139 Officer shall issue his warrants upon requisitions signed by the
- 140 proper person, officer or officers, in the manner provided by law.
- 141 **SECTION 13.** This act shall take effect and be in force from
- 142 and after July 1, 2025, and shall stand repealed from and after
- 143 June 30, 2025.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE STATE BOARD OF MEDICAL LICENSURE FOR THE FISCAL YEAR 2026.
