Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- 6 **SECTION 1.** (1) The Department of Finance and Administration
- 7 is authorized to purchase certain real property, and any
- 8 improvements thereon, located within the Capitol Complex in the
- 9 City of Jackson, Hinds County, Mississippi, known as the "East
- 10 Hamilton Street Properties," and being more particularly described
- 11 as follows:
- 12 (a) Property located at 303 East Hamilton Street in the
- 13 City of Jackson, Hinds County, Mississippi, designated as Parcel
- 14 83-9 consisting of approximately 0.32 acres as follows:

Beginning at a point on the South line of Hamilton Street 760.8 feet measured Westerly along the South line of Hamilton Street from the intersection of the South line of Hamilton Street with the West line of North West Street as both Streets were laid out and improved in the City of Jackson, Mississippi on May 24, 1951, and run thence westerly along the South line of Hamilton Street a distance of 52 feet to a point; thence turning to the left through an angle of 89 degrees 30 minutes run southerly 165 feet; thence run easterly parallel with the South line of Hamilton Street 52 feet; run thence northerly 165 feet to the point of beginning.

Beginning at a point on the South line of Hamilton Street 593.8 feet West of the West line of West Street as the said Streets are now laid out and improved; thence West along the South line of Hamilton Street 55 feet; turning to the left through an angle of 90 degrees 25 minutes run 165 feet to an iron pin; thence turning to the left through an angle of 89 degrees 35 minutes run easterly parallel with the South line of said Hamilton Street 47.5 feet to an iron pin; thence northerly in a straight line 165 feet more or less to the point of beginning.

The real property and improvements described in subsection (1) of this section shall not be purchased for an amount greater than the current fair market value as determined by the average of two (2) appraisals by qualified appraisers, at

- 91 least one (1) of whom shall be selected by the Department of
- 92 Finance and Administration, and both of whom shall be certified
- 93 and licensed by the Mississippi Real Estate Appraiser Licensing
- 94 and Certification Board.
- 95 (3) The Department of Finance and Administration is
- 96 authorized to negotiate any and all closing costs related to the
- 97 acquisition of these properties.
- 98 (4) The Department of Finance and Administration may correct
- 99 any discrepancies in the legal descriptions of the property
- 100 provided in this section.
- 101 (5) The real property and improvements acquired under this
- 102 section shall be used exclusively for state office space and
- 103 parking purposes.
- 104 **SECTION 2.** This act shall take effect and be in force from
- 105 and after its passage.

Further, amend by striking the title in its entirety and inserting in lieu thereof the following:

- AN ACT TO AUTHORIZE THE DEPARTMENT OF FINANCE AND
- 2 ADMINISTRATION TO PURCHASE CERTAIN REAL PROPERTY, AND ANY
- 3 IMPROVEMENTS THEREON, LOCATED ON EAST HAMILTON STREET IN JACKSON,
- 4 MISSISSIPPI; AND FOR RELATED PURPOSES.
