**Amend by striking all after the enacting clause and inserting
in lieu thereof the following:**

6 **SECTION 1.** Section 10, Chapter 534, Laws of 2024, is amended
7 as follows:

8 Section 10. Monies transferred pursuant to Sections 1 and 2
9 of this act into the 2024 Local Improvements Projects Fund shall
10 be disbursed by the Department of Finance and Administration,
11 pursuant to the authority to spend those monies granted by an
12 appropriation bill passed separately during the 2024 Regular
