HOUSE BILL NO. 42

1 AN ACT MAKING AN APPROPRIATION FOR THE PURPOSE OF FUNDING
2 K-12 AND OTHER RELATED EDUCATIONAL ACTIVITIES, INCLUDING CERTAIN
3 AGENCIES AND PROGRAMS, IN THE STATE OF MISSISSIPPI, FOR THE FISCAL
4 YEAR 2026.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 **SECTION 1.** The following sums, or so much of those sums as
7 may be necessary, are appropriated out of any money in the State
8 General Fund not otherwise appropriated, for the purpose of
9 funding K-12 and other related educational activities, including
10 certain agencies and programs, in the State of Mississippi, for
11 the fiscal year beginning July 1, 2025, and ending June 30, 2026,
12 as follows:

13 (a) To the State Board of Education for the purpose of
14 defraying the expenses of the State Department of Education, and
15 excluding the expenses of the Vocational and Technical Education
16 Division.....\$ 114,575,826.00.

17 (b) To the State Board of Education for the purpose of
18 defraying the expenses of the Vocational and Technical Education
19 Division of the State Department of Education.....

21 (c) To the State Board of Education for the purpose of
22 paying annual compensation to the Chickasaw Cession counties for
23 sixteenth section lands which they lost through sale by the state,

53 appropriated out of any money in the State Treasury to the credit
54 of the Health Care Expendable Fund to the State Department of
55 Education for the purpose of defraying the expenses of the
56 department for the Mississippi Eye Screening Program for providing
57 vision safety services.

"Personal Services," the State Personnel Board determines that the
agency has taken or will take an action that would cause the
agency to exceed the funds appropriated in this act when
annualized for Fiscal Year 2026 or increase the need for "Personal
Services" for Fiscal Year 2027, when annualized, the State
Personnel Board shall process no salary actions until such time as
the requirements of the provisions of this section are met with
the exception of new hires determined to be essential for the
agency.

When used in this section, "Vacancy Funding" shall mean funds
included in the Total Personal Services amount listed above and
designated for approved vacancies in Fiscal Year 2026. These funds
are to be utilized to increase the number of filled headcounts
that were authorized but unfilled as of the last day of Fiscal
Year 2025. If the agency fills additional headcounts after May 1,
2025, until the end of Fiscal Year 2025, the amount of available
Vacancy Funding may be proportionally reduced to reflect the
updated number of filled headcounts. The agency shall be
responsible for ensuring that "Vacancy Funding" is used to
increase headcounts and not for promotions, title changes,
in-range salary adjustments, or any other mechanism for increasing
salaries for current employees.



Any transfers or escalations shall be made in accordance with the terms, conditions, and procedures established by law or allowable under the terms set forth within this act. The State Personnel Board shall not escalate positions without written approval from the Department of Finance and Administration. The Department of Finance and Administration shall not provide written approval to escalate any funds for salaries and/or headcounts without proof of availability of new or additional funds above the appropriated level. Unless specifically noted, all Fiscal Year 2025 escalated headcounts have been accounted for and shall be converted to authorized time-limited headcounts.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

None of the funds herein appropriated shall be used in violation of the Internal Revenue Service's Publication 15-A relating to the reporting of income paid to contract employees, as interpreted by the Office of the State Auditor.

If the agency's total authorized headcount decreases from Fiscal Year 2025 to Fiscal Year 2026, it will be the agency's discretion as to what headcounts are removed.

The Legislature authorized one (1) new headcount, which is included in the authorized headcount above for Fiscal Year 2026.

SECTION 6. As used in this section, the term "Personal Services" shall mean funds provided under the major object of expenditure category Personal Services for Salaries, Wages, and Fringe Benefits. Funds in this category shall not be transferred to any other category.

It is the intention of the Legislature to ensure compliance with the Variable Compensation Plan, as outlined in Section 25-9-147, Mississippi Code of 1972. Payment from these funds shall be in accordance with the Variable Compensation Plan promulgated by the Mississippi State Personnel Board. It is the Legislature's intention that no employee's salary falls below the minimum salary established by the Mississippi State Personnel Board.

The State Personnel Board shall determine and publish the projected annual cost of "Personal Services" based on monthly and year-to-date payroll expenditures in compliance with the provisions of this act.

With the funds herein appropriated, it shall be the agency's responsibility to ensure that no single personnel action or combination of personnel actions, when annualized, exceeds the Fiscal Year 2026 appropriation for "Personal Services" with the exception of escalated funds. Further, it shall be the agency's responsibility to ensure that funds required to be appropriated for "Personal Services" for Fiscal Year 2027 do not exceed Fiscal Year 2026 funds appropriated for that purpose unless programs or positions are added to the agency's Fiscal Year 2026 budget by the Mississippi Legislature.

SECTION 10. Of the funds appropriated in this act, an amount not to exceed One Million Twenty-three Thousand Five Hundred Seventy-four Dollars (\$1,023,574.00) is authorized for the support of vocational and technical education programs as authorized in



417 Section 37-31-13, Mississippi Code of 1972, for a period in excess
418 of ten (10) months in a calendar year.

419 **SECTION 11.** It is the intention of the Legislature that the
420 Vocational and Technical Education Division of the State
421 Department of Education shall, with the funds appropriated in
422 Section 1, transfer no more than Seventy-five Thousand Dollars
423 (\$75,000.00) to the Mississippi Soil and Water Conservation
424 Commission for the purpose of providing matching funds to purchase
425 soil conservation equipment.

426 **SECTION 12.** Of the funds appropriated in this act, no more
427 than One Hundred Seventy-five Thousand Dollars (\$175,000.00) is
428 provided for the purpose of supporting the Future Farmers of
429 America Center.

430 **SECTION 13.** The State Department of Education shall transfer
431 the designated amounts to the appropriate entities, which shall
432 assume full responsibility for the expenditure of these funds in
433 accordance with state laws and accept all responsibility for any
434 improper expenditure, for the following:

453 **SECTION 14.** It is the intention of the Legislature that of
454 the funds provided for Other Early Learning Programs in Section
455 4(a), Thirteen Million Dollars (\$13,000,000.00) is included for
456 the Mississippi Department of Education to provide grant
457 opportunities for Other Early Learning Programs through public
458 schools including other public school preschool programs not
459 participating in Early Learning Collaboratives.

460 **SECTION 15.** Of the funds appropriated in this act, an amount
461 not to exceed One Million Five Hundred Thousand Dollars
462 (\$1,500,000.00) shall be used for technological methods for
463 agricultural programs, computer science, engineering or robotic
464 engineering programs and equipment upgrades and Mississippi
465 Elementary (ME) STEM and STEAM programs from the Career and
466 Technical Education Division of the State Department of Education.



All programs must meet Mississippi Science Standards and/or
College and Career Standards.

Of the funds appropriated in this section, an amount not to
exceed One Million Dollars (\$1,000,000.00) shall be distributed to
the Mississippi State University Center for Cyber Education and
used for computer science programs development and teacher
training for elementary schools, middle schools, and high schools
for the purpose of developing K-12 computer science curricula,
including both academic and career and technical education
programs, developing and delivering teacher training, and working
with the State Board of Education and Institutions of Higher
Learning in the state to develop teacher preparation programs for
computer science endorsements. All programs must meet the 2018
Mississippi Computer Science Standards and/or Mississippi College
and Career Standards.

SECTION 16. It is the intention of the Legislature that
computer science courses may be taught by certified teacher or for
elementary level classes, computer science courses may be taught
by teachers who are trained by the district in computer science
instruction.

SECTION 17. Of the funds appropriated in Section 1, the sum
of Sixty-two Thousand One Hundred Ninety-one Dollars (\$62,191.00),
which is the aggregate sum that the school districts in the
Chickasaw Cession receive annually from interest payments from the
Chickasaw School Fund under Section 212, Mississippi Constitution



of 1890, shall be deducted from the allocations to the school districts as provided in Section 29-3-137, Mississippi Code of 1972, and shall be distributed among the school districts in the Chickasaw Cession by the State Department of Education in the manner that those interest payments were distributed during Fiscal Year 1985.

SECTION 18. Of the funds provided in this act for the purpose of funding the Mississippi Student Funding Formula, the Student Base Amount in Fiscal Year 2026 shall be Six Thousand Eight Hundred Forty-seven Dollars and Thirty-three Cents (\$6,847.33).

SECTION 19. With the funds provided in this act, it is the intention of the Legislature that School Attendance Officers and academic teachers at the Mississippi School for the Deaf and the Mississippi School for the Blind shall receive their annual increment.

SECTION 20. It is the intention of the Legislature that the State Board of Education shall maintain complete accounting and personnel records related to the expenditure of all funds appropriated in this act and that those records shall be in the same format and level of detail as maintained for Fiscal Year 2025. It is further the intention of the Legislature that the budget requests for Fiscal Year 2027 shall be submitted to the Joint Legislative Budget Committee in a format and level of detail comparable to the format and level of detail provided during the



Fiscal Year 2026 budget request process for each agency and institution appropriated funds within the provisions of this act.

SECTION 21. Of the funds appropriated in Section 1(a) to the State Board of Education, not less than Twenty-four Million Eighty Thousand Dollars (\$24,080,000.00) shall be used for National Board Certification. Of this amount, Seven Hundred Thousand Dollars (\$700,000.00) shall be used for the World Class Teacher Program providing instruction and assistance to teachers seeking National Board Certification.

SECTION 22. Of the funds appropriated in Section 1 and Section 4(a) not less than Seventeen Million Five Hundred Fifty-eight Thousand Dollars (\$17,558,000.00) shall be used for the Educable Child Program. It is the intention of the Legislature that the State Board of Education shall allocate funding for the Educable Child Program based upon a recalculated formula in a manner to include only those billable days funded through appropriation of state funds and not District funds. It is the intent of the Legislature that the Educable Child funds shall be exempt from budget cuts made to the Department of Education by the Legislature and/or the Office of the Governor.

SECTION 23. Of the funds appropriated in Section 1(a) and Section 4(a), not less than Five Million Dollars (\$5,000,000.00) shall be used for the Education Scholarship Account (ESA) Program. It is the intent of the Legislature that the Education Scholarship



Account (ESA) funds shall not be reduced by the State Department of Education and/or the Office of the Governor.

SECTION 24. The public school districts of the state are authorized at their discretion to pay with local funds one hundred percent (100%) of the cost of the health insurance premiums of the State and School Employees Health Insurance Plan for all retired members of the Public Employees' Retirement System who are employed as school bus drivers by the school districts. It is the intention of the Legislature that no state funds shall be used for this purpose.

SECTION 25. It is the intention of the Legislature that whenever two (2) or more bids are received by this agency for the purchase of commodities or equipment, and whenever all things stated in those received bids are equal with respect to price, quality and service, the Mississippi Industries for the Blind shall be given preference. A similar preference shall be given to the Mississippi Industries for the Blind whenever purchases are made without competitive bids.

SECTION 26. Of the funds appropriated in Section 1, not less than Six Million Four Hundred Fourteen Thousand Eight Hundred Ninety-eight Dollars (\$6,414,898.00) shall be used for the Compulsory School Attendance Office and School Attendance Officers.

SECTION 27. Of the funds appropriated in this act, it is the intention of the Legislature that Three Million Sixty Thousand



566 Dollars (\$3,060,000.00) shall be used for the Mary
567 Kirkpatrick-Mary Sprayberry Public School Nurse Program. The
568 amount of Three Million Sixty Thousand Dollars (\$3,060,000.00) is
569 provided from the Department of Health.

570 **SECTION 28.** It is the intention of the Legislature that the
571 State Board of Education shall charge a fee for room and board for
572 students who enroll in the Mississippi School for Mathematics and
573 Science and the Mississippi School of Arts. Such fees will be
574 waived for any student enrolled in the State Children's Health
575 Insurance Program. The amount of such fees shall be Five Hundred
576 Dollars (\$500.00) for each semester.

577 **SECTION 29.** It is the intent of the Legislature that each
578 eligible employee who meets the National Board requirements under
579 Section 37-19-7(2), Mississippi Code of 1972, shall be paid the
580 full supplement and that such supplement shall be included on a
581 prorated basis in the employee's monthly paycheck.

582 **SECTION 30.** It is the intention of the Legislature that the
583 Mississippi Department of Education may loan any general or
584 special source fund amount, not to exceed Five Million Dollars
585 (\$5,000,000.00), to any school district for the purpose of
586 providing funds to school districts through the Emergency
587 Assistance Fund as outlined in Section 37-17-6, Mississippi Code
588 of 1972, during the period beginning July 1, 2025, and ending
589 June 30, 2026. The school districts receiving these loans shall



590 repay the Mississippi Department of Education the amount of the
591 loan on or before June 30, 2026.

592 **SECTION 31.** Of the funds appropriated in Section 1(a), Two
593 Million One Hundred Sixty-five Thousand Two Hundred Ninety Dollars
594 (\$2,165,290.00) is provided for the operation of a State-Wide
595 Synchronous Instructional Project.

596 **SECTION 32.** Of the funds appropriated in Section 1(a), Seven
597 Hundred Thousand Dollars (\$700,000.00) shall be transferred to the
598 Board of Health no later than December 31, 2025.

599 **SECTION 33.** Any school district receiving funds through Save
600 the Children may provide a ten percent (10%) match from local
601 funds for implementation of the program.

602 **SECTION 34.** Of the funds appropriated in Section 1(a), Two
603 Million Dollars (\$2,000,000.00) is provided for the Mississippi
604 Community Oriented Policing Services in Schools (MCOPS) grant
605 program. A portion of these funds not to exceed one percent (1%)
606 may be used for training and administrative costs related to
607 oversight and auditing of the program.

608 **SECTION 35.** Of the funds appropriated in Section 1(a) and
609 Section 2(a), Twenty-nine Million Dollars (\$29,000,000.00) is
610 provided for an Early Childhood Education Initiative program. The
611 funding shall be provided to early learning collaboratives in
612 Fiscal Year 2026 as follows: no less than Two Thousand Five
613 Hundred Dollars (\$2,500.00) per student in a full-day program and
614 no less than One Thousand Two Hundred Fifty Dollars (\$1,250.00)



per student in a half-day program. Funds must be matched as provided by Section 37-21-51, Mississippi Code of 1972.

SECTION 36. Of the funds appropriated in Section 1(a) and Section 4(a), Fifteen Million Ninety-four Thousand Five Hundred Dollars (\$15,094,500.00) shall be used for the Literacy Initiative and Assessment and monitoring and evaluating the adoption and implementation of high-quality instructional materials that have been reviewed through the approved state process and distributed through regional textbook depository as outlined in Section 37-43-23, Mississippi Code of 1972.

SECTION 37. Of the funds appropriated herein, funding is provided for the ACT test, which is the college readiness portion of the state accountability model.

SECTION 38. Of the funds appropriated in Section 1(a), Two Million Seven Hundred Fifty Thousand One Hundred Thirty-two Dollars (\$2,750,132.00) shall be used for the Mississippi School of the Arts and Four Million Thirty-three Thousand Seven Hundred Seventy-five Dollars (\$4,033,775.00) shall be used for the Mississippi School for Mathematics and Science. It is the intention of the Legislature that of the funds appropriated in Section 1(a) for the Mississippi School of the Arts, One Million Three Hundred Seventy-five Thousand Sixty-six Dollars (\$1,375,066.00) shall be paid to the school no later than July 10, 2025, and One Million Three Hundred Seventy-five Thousand Sixty-six Dollars (\$1,375,066.00) shall be paid no later than



January 10, 2026. All funds appropriated from Section 4(a) for the Mississippi School of the Arts shall be paid to the school each month within ten (10) working days after such amount was received by the Department of Education. It is the intention of the Legislature that the State Board of Education shall not reduce the appropriated amounts provided in this act for the Mississippi School of the Arts and the Mississippi School for Mathematics and Science.

SECTION 39. Of the funds appropriated in Section 1(b) and Section 2(b), Five Hundred Thousand Dollars (\$500,000.00) is provided for career and technical grants to schools for qualified students as authorized by Section 37-153-15, Mississippi Code of 1972.

SECTION 40. Of the funds appropriated in this act, the following amounts shall be available to the Schools for the Blind and Deaf: Ten Million Five Hundred Thirty-six Thousand Eight Hundred Forty-two Dollars (\$10,536,842.00) from Section 1(a), Two Million Five Hundred Fifty-seven Thousand Thirty-seven Dollars (\$2,557,037.00) from Section 4(a), and Two Million Four Hundred Fifty-nine Thousand Seven Hundred Twenty-five Dollars (\$2,459,725.00) from Section 2(a).

SECTION 41. Of the funds appropriated in Section 1(a) of this act, One Million Four Hundred Thousand Dollars (\$1,400,000.00) is provided for the continuation of the current school safety platform.



665 **SECTION 42.** Of the funds appropriated in this act, an amount
666 not to exceed Four Million One Hundred Seventy-one Thousand Three
667 Hundred One Dollars (\$4,171,301.00) is authorized to fully fund
668 the contract between the Department of Education and the Research
669 & Curriculum Unit at Mississippi State University to fund career
670 and technical curricula, services to secondary schools and career
671 and technical assessments.

672 **SECTION 43.** Of the funds appropriated in Section 1(b) to the
673 State Board of Education, Five Hundred Sixty-two Thousand Nine
674 Hundred Ninety-nine Dollars (\$562,999.00) is provided for
675 secondary career and technical education instructors teaching at
676 post-secondary institutions.

677 **SECTION 44.** In addition to all other funds appropriated
678 herein, the following sum, or so much thereof as may be necessary,
679 is hereby appropriated out of any money in the State Treasury to
680 the credit of the Charter School Authorizer Board for operational
681 expenses for the fiscal year beginning July 1, 2025, and ending
682 June 30, 2026.....\$ 1,400,000.00.

683 **SECTION 45.** Of the funds appropriated in Section 1(b), One
684 Million Four Hundred Thirty-two Thousand Eight Hundred Seventy-two
685 Dollars (\$1,432,872.00) shall be provided for new Career and
686 Technical Education Programs as determined by the Division of
687 Vocational and Technical Education at the Mississippi Department
688 of Education. Of the funds appropriated to the department for



689 these programs, no amount shall be expended by the department to
690 defray administrative costs.

691 **SECTION 46.** The Mississippi Department of Education shall
692 provide an annual report detailing the funding of industry
693 certifications and the anticipated industry certifications that
694 will be achieved in the upcoming fiscal year to the Legislative
695 Budget Office and the Legislature no later than January 15, 2026.

696 **SECTION 47.** The following sum, or so much thereof as may be
697 necessary, is reappropriated out of any money in the Education
698 Enhancement Fund not otherwise appropriated, for the Mississippi
699 Department of Education for the purpose of reauthorizing the
700 expenditure of Education Enhancement Funds as authorized in House
701 Bill 1823, 2024 Regular Session, for the fiscal year beginning
702 July 1, 2025, and ending June 30, 2026.....\$ 30,117,393.00.

703 This reappropriation is made for the purpose of reauthorizing
704 the expenditure of funds as allocated herein:

705 a. Instructional Materials.....\$ 2,732,190.00.
706 b. Early Learning Collaboratives.....\$ 15,485,203.00.
707 c. Other Early Learning Programs.....\$ 11,900,000.00.

708 Notwithstanding the amount reappropriated under this section,
709 the amount that may be expended under the authority of this
710 section shall not exceed the unexpended balance of the funds
711 remaining as of June 30, 2025, from the amount authorized for the
712 previous fiscal year. In addition, this reappropriation shall not
713 change the purpose for which the funds were originally authorized.



714 **SECTION 48.** With the funds appropriated herein, the
715 Mississippi Department of Education is authorized to make payments
716 for expenses incurred during prior fiscal years for an amount not
717 to exceed Fifteen Thousand Three Hundred Nine Dollars and
718 Eighty-six Cents (\$15,309.86). These payments are for previous
719 year invoices for Accelerate Learning Inc. and McGraw Hill LLC.

720 **SECTION 49.** It is the intent of the Legislature that each
721 eligible professional school counselor employee who meets the year
722 of teaching experience requirements under Section 37-151-5(m),
723 Mississippi Code of 1972, shall be considered having a year of
724 experience for purposes of the annual experience salary increment.

725 **SECTION 50.** The money appropriated in this act shall be paid
726 by the State Treasurer out of any money in the proper fund or
727 funds as set forth in this act, upon warrants issued by the State
728 Fiscal Officer; and the State Fiscal Officer shall issue warrants
729 upon requisitions signed by the proper person, officer or officers
730 in the manner provided by law.

731 **SECTION 51.** This act shall take effect and be in force from
732 and after July 1, 2025.
