HOUSE BILL NO. 355 (As Passed the House)

- AN ACT TO AMEND SECTION 43-27-203, MISSISSIPPI CODE OF 1972, TO AUTHORIZE THE MISSISSIPPI NATIONAL GUARD TO AWARD ADULT HIGH SCHOOL DIPLOMAS TO YOUTH CHALLENGE PROGRAM PARTICIPANTS WHO MEET MINIMUM ACADEMIC REQUIREMENTS FOR GRADUATION; AND FOR RELATED PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 43-27-203, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 43-27-203. (1) There is created under the Mississippi
- 10 National Guard a program to be known as the "Youth Challenge
- 11 Program." The program shall be an interdiction program designed
- 12 for children determined to be "at risk" by the National Guard.
- 13 (2) The Mississippi National Guard shall implement and
- 14 administer the Youth Challenge Program and shall promulgate rules
- 15 and regulations concerning the administration of the
- 16 program * * *. The National Guard shall prepare written
- 17 guidelines concerning the nomination and selection process of
- 18 participants in the program, and such guidelines shall include a
- 19 list of the factors considered in the selection process.
- 20 (3) Participation in the Youth Challenge Program shall be on
- 21 a voluntary basis. No child may be sentenced by any court to
- 22 participate in the program; however, a youth court judge may refer
- 23 the program to a child when, under his determination, such program
- 24 would be sufficient to meet the needs of the child.
- 25 (4) The Mississippi National Guard, under the auspices of
- 26 the Challenge Academy, may award an adult high school diploma to
- 27 <u>each participant who meets the requirements for a general</u>

- 28 <u>educational development (GED) equivalent under the policies and</u>
- 29 guidelines of the GED Testing Service of the American Council on
- 30 Education and any other minimum academic requirements prescribed
- 31 by the National Guard and Challenge Academy for graduation from
- 32 <u>the Youth Challenge Program. Participants in the program who do</u>
- 33 not meet the minimum academic requirements may be awarded a
- 34 special certificate of attendance. The Mississippi National Guard
- 35 and the Challenge Academy shall establish rules and regulations
- 36 for awarding the adult high school diploma and shall prescribe the
- 37 form for such diploma and the certificate of attendance.
- 38 (5) The Mississippi National Guard may accept any available
- 39 funds that may be used to defray the expenses of the program,
- 40 including, but not limited to, federal funding, public or private
- 41 funds and any funds that may be appropriated by the Legislature
- 42 for that purpose.
- 43 SECTION 2. This act shall take effect and be in force from
- 44 and after July 1, 1999.
