- 3 COMMISSION; AND FOR RELATED PURPOSES.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 SECTION 1. Section 21-31-1, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 21-31-1. (1) A civil service commission is * * * created in
- 8 every municipality described in subsection (2) which has a full
- 9 paid fire and police department.
- 10 (2) The provisions of subsection (1) of this section shall
- 11 apply to:
- 12 (a) Any municipality, operating under a commission form
- 13 of government, and having a population of not less than fourteen
- 14 thousand (14,000), according to the federal census of 1940;
- 15 (b) Any municipality, under whatever form of
- 16 government, having a population of not less than twenty-four
- 17 thousand (24,000), according to the federal census of 1940, and
- 18 situated in counties having a national military park;
- 19 (c) Any municipality, operating under the commission
- 20 form of government, and having a population of not less than ten
- 21 thousand five hundred (10,500) nor more than eleven thousand
- 22 (11,000), according to the federal census of 1950;
- 23 (d) Any municipality, having an aldermanic commission
- 24 or city manager form of government, and having a population of not
- 25 less than three thousand eight hundred eighty-one (3,881) at the
- 26 1960 federal census, and situated on the Mississippi Gulf Coast;

- 27 (e) Any municipality with its corporate limits being
- 28 bounded on one (1) side by the Mississippi River and being located
- 29 in a county having an assessed valuation in excess of Forty
- 30 Million Dollars (\$40,000,000.00) but less than Fifty Million
- 31 Dollars (\$50,000,000.00) and having a total population in excess
- 32 of thirty-seven thousand five hundred (37,500), according to the
- 33 latest federal census; * * *
- 34 (f) Any municipality, operating under special charter,
- 35 and in which there is located a state-supported college for
- 36 women; * * *
- 37 (g) Any municipality having a population of more than
- 38 ten thousand (10,000) according to the federal census of 1970,
- 39 which is located within a Class 1 county in which U.S. Highway 51
- 40 and U.S. Highway 98 intersect and bounded on the south by the
- 41 State of Louisiana; and
- 42 (h) Any municipality, bordering on the Escatawpa River,
- 43 <u>having an aldermanic commission form of government and having a</u>
- 44 population of not less than seventeen thousand eight hundred
- 45 thirty-seven (17,837) according to the 1990 federal census.
- 46 SECTION 2. This act shall take effect and be in force from
- 47 and after July 1, 1999.
