HOUSE BILL NO. 1693

- AN ACT TO AMEND CHAPTER 995, LOCAL AND PRIVATE LAWS OF 1998,
- 2 TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF SOUTHAVEN TO PAY COMPENSATION TO SUMMERSHILL FIRE DISTRICT FOR TERRITORY
- 4 REMOVED FROM ITS FIRE PROTECTION DISTRICT; AND FOR RELATED
- 5 PURPOSES.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Chapter 995, Local and Private Laws of 1998, is
- 8 amended as follows:
- 9 Section 1. (1) Subject to the provisions of subsection (2)
- 10 of this section, the governing authorities of the City of
- 11 Southaven, Mississippi, in their discretion, are authorized to
- 12 supplement the fire protection services of the Summershill Fire
- 13 District for territory removed from its fire district.
- 14 (2) * * * Such agreement shall be entered into
- 15 <u>simultaneously with</u> the removal of <u>the</u> property tax <u>imposed for</u>
- 16 the fire district from the individual landowners * * *.
- 17 (3) (a) By agreement of the parties, the City of Southaven,
- 18 <u>Mississippi, shall pay to Summershill Fire Protection District, as</u>
- 19 compensation to the district for its loss of tax revenue and dues,
- 20 <u>an annual amount not to exceed Fourteen Thousand Nine Hundred</u>
- 21 Eighty-Seven Dollars and Ninety-three Cents (\$14,987.93), from any
- 22 available funds, during fiscal year 2000 and each fiscal year
- 23 <u>thereafter for the next fourteen (14) years or until some party</u>
- 24 <u>retires or assumes the current debt of the Summershill Fire</u>
- 25 <u>Department</u>.
- 26 (b) The City of Southaven, Mississippi, shall be fully
- 27 and wholly responsible for the fire protection within its

- 28 <u>corporate limits located within the Summershill Fire Protection</u>
- 29 <u>District and the Summershill Fire Protection District shall be</u>
- 30 <u>relieved of any further responsibility for fire protection in</u>
- 31 those areas that are located within the city limits of the City of
- 32 <u>Southaven, Mississippi, on or before the effective date of this</u>
- 33 <u>act.</u>
- 34 SECTION 2. This act shall take effect and be in force from
- 35 and after its passage.
