HOUSE BILL NO. 1719

AN ACT TO AUTHORIZE THE GOVERNING AUTHORITIES OF THE CITY OF 1 2 MIZE, MISSISSIPPI, AND THE GOVERNING AUTHORITIES OF TAYLORSVILLE, 3 MISSISSIPPI, TO LEVY AN ASSESSMENT, IN ADDITION TO ANY OTHER ASSESSMENTS AND COURT COSTS, FOR EACH MISDEMEANOR CASE PROCESSED THROUGH THE MUNICIPAL COURT OF THE CITY; TO AUTHORIZE THE BOARD OF 4 5 SUPERVISORS OF SMITH COUNTY, MISSISSIPPI, TO LEVY AN ASSESSMENT, IN ADDITION TO ANY OTHER ASSESSMENTS, AND COURT COSTS, FOR EACH 6 7 8 MISDEMEANOR CASE PROCESSED THROUGH THE SMITH COUNTY COURT SYSTEM; 9 TO PROVIDE THAT THE AVAILS OF SUCH ADDITIONAL ASSESSMENTS SHALL BE 10 USED TO ASSIST IN THE FUNDING OF SMITH COUNTY CRIMESTOPPERS; AND 11 FOR RELATED PURPOSES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 12 SECTION 1. (1) The governing authorities of the City of 13 Mize, Mississippi, in their discretion, are authorized, by 14 resolution duly adopted and entered on the minutes of the 15 16 governing authorities, to levy an assessment, in addition to any 17 other assessments and court costs, in the amount of One Dollar (\$1.00) per case for each misdemeanor case processed through the 18 19 municipal court of such city.

20 (2) The avails of the additional assessment imposed pursuant 21 to subsection (1) of this section shall be paid by the city to 22 Smith County Crimestoppers for use in procuring information to aid 23 authorities in the capture and conviction of persons committing 24 crimes in Mize, Mississippi.

25 SECTION 2. (1) The governing authorities of the City of 26 Taylorsville, Mississippi, in their discretion, are authorized, by 27 resolution duly adopted and entered on the minutes of the 28 governing authorities, to levy an assessment, in addition to any 29 other assessments and court costs, in the amount of One Dollar 30 (\$1.00) per case for each misdemeanor case processed through the 31 municipal court of such city.

No. 1719 99\HR07\R1009.1 PAGE 1 32 (2) The avails of the additional assessment imposed pursuant 33 to subsection (1) of this section shall be paid by the city to 34 Smith County Crimestoppers for use in procuring information to aid 35 authorities in the capture and conviction of persons committing 36 crimes in Taylorsville, Mississippi.

37 SECTION 3. (1) The Board of Supervisors of Smith County, 38 Mississippi, in their discretion, are authorized, by resolution 39 duly adopted and entered on the minutes of the governing 40 authorities, to levy an assessment, in addition to any other 41 assessments and court costs, in the amount of One Dollar (\$1.00) 42 per case for each misdemeanor case processed through the courts in 43 the Smith County Court System.

44 (2) The avails of the additional assessment imposed pursuant 45 to subsection (1) of this section shall be paid by the county to 46 Smith County Crimestoppers for use in procuring information to aid 47 authorities in the capture and conviction of persons committing 48 crimes in Smith County, Mississippi.

49 SECTION 4. This act shall take effect and be in force from 50 and after its passage.
