17	was elected in 1972, and has now spent over 50 years of service to
18	the Mississippi agricultural industry; and

20	Richard T. Wax is a former president of the Southern Seedsmen's
21	Association, the Southern Field Seed Council and was appointed by
22	the American Seed Trade Association to the Panel of Arbitrators of

24	WHEREAS, Barry Wax, Terry Wax Myatt and John Wax, the
25	children of Mr. and Mrs. Richard T. Wax, are now actively involved
26	in the family business as the fourth generation of the Wax Company
