## SENATE BILL NO. 2890

1	AN ACT TO AMEND SECTION 57-1-55, MISSISSIPPI CODE OF 1972, TO
2	AUTHORIZE THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT TO
3	EMPLOY LICENSED REAL ESTATE BROKERS AND APPRAISERS NECESSARY FOR
4	THE INDUSTRIAL DEVELOPMENT OF ANY REAL ESTATE UNDER THE OWNERSHIP
5	OR CONTROL OF THE DEPARTMENT; AND FOR RELATED PURPOSES.

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 7 SECTION 1. Section 57-1-55, Mississippi Code of 1972, is
- 8 amended as follows:
- 9 57-1-55. (1) The Department of Economic and Community
- 10 Development shall have the following general powers and duties:
- 11 To develop and manage programs which enhance the climate for
- 12 economic growth through assistance to private sector businesses,
- 13 local communities and individuals, and through an extensive
- 14 national and international marketing effort.
- 15 (2) The Department of Economic and Community Development
- 16 shall have the following general powers and duties with respect to
- 17 economic development:
- 18 (a) To plan, supervise and direct an active program of
- 19 solicitation of industries to locate within the state;
- 20 (b) To prepare, maintain and disseminate information
- 21 which is needed by companies in evaluating site locations;
- 22 (c) To consult with, advise and assist prospective
- 23 industries wishing to locate within the state;
- 24 (d) To encourage new or expanding industries, which
- 25 will add to the economy, to locate within the state;
- 26 (e) To maintain a coordinated liaison function with
- 27 other development groups, including state and federal agencies,

- 28 and planning and development districts, utility companies,
- 29 chambers of commerce and railroads;
- 30 (f) To assist communities and counties within the state
- 31 in preparation for economic growth;
- 32 (g) To assist new and existing business and industry
- 33 and encourage their development and expansion;
- 34 (h) To plan and conduct a nationwide advertising
- 35 program promoting the state to prospective industry;
- 36 (i) To work with economic development agencies of the
- 37 federal government in areas of industrial development and provide
- 38 information to industrial prospects regarding the availability of
- 39 federal funds and assistance;
- 40 (j) To work with the Department of Corrections,
- 41 pursuant to the provisions of Section 47-5-501 et seq., in
- 42 identifying and evaluating acceptable industries and businesses
- 43 and in acting as an agent of the Department of Corrections by
- 44 communicating with such concerns and aggressively soliciting their
- 45 participation in the Correctional Industries Work Program;
- 46 (k) To perform related work as required;
- 47 (1) To disseminate information about financial and
- 48 other programs of the Department of Economic and Community
- 49 Development that will assist in the creation or expansion of
- 50 industries processing wood products in this state;
- 51 (m) To market processed and raw agricultural products
- 52 domestically and abroad; \* \* \*
- 53 (n) To aid in the establishment of business incubation
- 54 centers by private business interests, not for profit
- 55 corporations, and/or governmental entities. The department may
- 56 provide funds by contract for the establishment of business
- 57 incubation centers and may contract for space in which business
- 58 incubation centers will be located. Business incubation centers
- 59 are defined as facilities and support services that encourage the
- 60 establishment of successful small businesses by providing a
- 61 short-term sheltered environment. The department may solicit and
- 62 accept grants and other financial aid or support from private or
- 63 public sources to aid in the development of business incubation
- 64 centers. In addition, advice and assistance to established

65	business incubation centers may be provided by the department; and
66	(o) To employ licensed real estate brokers and
67	appraisers necessary for the industrial development of any real
68	estate under the ownership or control of the Department of
69	Economic and Community Development.
70	SECTION 2. This act shall take effect and be in force from
