## SENATE BILL NO. 3226

- AN ACT TO PROVIDE THE CITY OF CORINTH, MISSISSIPPI, AND ALCORN COUNTY, MISSISSIPPI, WITH THE POWERS TO EFFECTIVELY OPERATE THE CORINTH-ALCORN COUNTY CONVENTION AND AGRI-EXPOSITION CENTER 1 2

- JOINTLY AND/OR SEPARATELY; AND FOR RELATED PURPOSES. 4
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. For the purpose of this act, the following terms 6
- 7 shall have the meanings ascribed herein, unless the context
- 8 otherwise requires:
- (a) "City" shall mean the Mayor and Board of Aldermen 9
- 10 of the City of Corinth, Mississippi.
- "County" shall means the Board of Supervisors of 11
- 12 Alcorn County, Mississippi.
- 13 (c) "Facility" shall mean a suitable building,
- 14 multipurpose in use, including, but not limited to, recreational,
- 15 commercial, industrial, entertainment or other civic related
- purposes, together with necessary adjacent buildings, grounds, 16
- 17 parking areas, access ways, fences, appurtenances and
- improvements. 18
- "Convention Center" shall mean the Corinth-Alcorn 19
- 20 County Convention and Agri-Exposition Center.
- SECTION 2. The city and county, jointly and/or separately, 2.1
- are hereby authorized to plan, acquire, establish, develop, 22
- 23 construct, enlarge, improve, promote, advertise, maintain, fund,
- equip, operate, manage, lease, regulate, protect and police the 24
- 25 convention center, or other property, real or personal, to be
- 26 jointly acquired, controlled and operated and to lease any
- property, real or personal, inside or outside the boundaries of 27

- 28 the convention center site as they may deem necessary.
- 29 SECTION 3. The city and county are hereby authorized to
- 30 employ personnel, obtain supplies, furnishings and other
- 31 facilities as is necessary for the efficient operation of the
- 32 convention center and the care of supporting property, and to
- 33 employ such professional services as from time to time shall be
- 34 deemed necessary in the conduct of the business of operating the
- 35 convention center and the protection of the properties.
- 36 SECTION 4. The city and county are hereby authorized to
- 37 receive and expend revenues from any source and to negotiate and
- 38 enter into any contracts necessary for the efficient operation of
- 39 the convention center.
- 40 SECTION 5. The city and county are hereby authorized to
- 41 delegate all the powers given to them by this act to a board,
- 42 commission, joint board or joint commission, established by them
- 43 to operate and manage the convention center.
- SECTION 6. This act shall be deemed to be full and complete
- 45 authority for the exercise of the powers herein granted.
- 46 SECTION 7. This act shall take effect and be in force from
- 47 and after its passage.
