## HOUSE BILL NO. 244 (As Passed the House)

- AN ACT TO REENACT SECTIONS 69-43-1 THROUGH 69-43-11,
  MISSISSIPPI CODE OF 1972, WHICH CREATE THE RATITE COUNCIL AND
  PROMOTION BOARD AND PRESCRIBE ITS DUTIES AND POWERS; TO AMEND
  SECTION 69-43-13, MISSISSIPPI CODE OF 1972, TO EXTEND THE DATE OF
  REPEAL ON THE RATITE COUNCIL AND PROMOTION BOARD; AND FOR RELATED
  PURPOSES.
- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 SECTION 1. Section 69-43-1, Mississippi Code of 1972, is
- 9 reenacted as follows:
- 10 69-43-1. The purpose of this act is to promote the growth
- 11 and development of the ratite industry in Mississippi by
- 12 advertisement and promotion of products, market development,
- 13 research and producer education, thereby promoting the general
- 14 welfare of the people of this state.
- 15 SECTION 2. Section 69-43-3, Mississippi Code of 1972, is
- 16 reenacted as follows:
- 17 69-43-3. (1) The Mississippi Ratite Council and Promotion
- 18 Board is created to be composed of five (5) members as follows:
- 19 Two (2) members elected by the Mississippi State Emu Association;
- 20 two (2) members elected by the Mississippi Ostrich Association;
- 21 and one (1) member appointed by the Commissioner of Agriculture
- 22 and Commerce. Each member shall serve a term of one (1) year to
- 23 coincide with the calendar year. Vacancies which occur shall be
- 24 filled in the same manner as the original elections or
- 25 appointments were made.
- 26 (2) The members of the board shall meet and organize
- 27 immediately after their election or appointment and shall elect a
- 28 chairman, vice chairman and secretary-treasurer from the

- 29 membership of the board, whose duties shall be those customarily
- 30 exercised by such officers or specifically designated by the
- 31 board. The chairman, vice chairman and secretary-treasurer shall
- 32 be bonded in an amount not less than Twenty Thousand Dollars
- 33 (\$20,000.00). The cost of the bonds shall be paid from the funds
- 34 received under the provisions of Section 3 of this act. Such bond
- 35 shall be a security for any illegal act of any member of the board
- 36 and recovery thereon may be had by the state for any injury by
- 37 such illegal act of such member. The board may establish rules
- 38 and regulations in accordance with the Administrative Procedures
- 39 Act for its own government and the administration of the affairs
- 40 of the board.
- 41 SECTION 3. Section 69-43-5, Mississippi Code of 1972, is
- 42 reenacted as follows:
- 43 69-43-5. (1) There is imposed and levied an assessment not
- 44 to exceed Eight Dollars (\$8.00) per ratite slaughtered within the
- 45 State of Mississippi. Such assessment shall be deducted by the
- 46 processor from the amount paid the producer at the first point of
- 47 processing or sale.
- 48 (2) The assessment imposed and levied by this section shall
- 49 be payable to and collected by the Mississippi Department of
- 50 Agriculture and Commerce, hereafter referred to as "the
- 51 department," from the processor of such ratites at the first point
- 52 of processing or sale. The proceeds of the assessment collected
- 53 by the department shall be deposited monthly with the State
- 54 Treasurer in a special fund to be established as the "Mississippi
- 55 Ratite Promotion Fund, " and disbursement therefrom shall be made
- 56 upon warrants issued by the State Fiscal Officer upon requisitions
- 57 signed by the Chairman and Secretary-Treasurer of the Mississippi
- 58 Ratite Council and Promotion Board, or their designee, in the
- 59 manner provided by law. The State Treasurer shall invest such
- 60 proceeds and any interest earned thereon shall be credited to such
- 61 special fund and shall not be deposited in the State General Fund.
- 62 (3) The Mississippi Department of Agriculture and Commerce
- 63 shall submit to the Mississippi Ratite Council and Promotion Board
- 64 a budget detailing and justifying the administrative costs of the
- 65 department in administering the provisions of this chapter, and

- 66 such budget must be approved by the Mississippi Ratite Council and
- 67 Promotion Board by April 1 of each year. The amount withheld by
- 68 the department, which shall not exceed three and one-half percent
- 69 (3-1/2%) of the gross amount collected, must be approved by the
- 70 Mississippi Ratite Council and Promotion Board by July 1 of each
- 71 year.
- 72 SECTION 4. Section 69-43-7, Mississippi Code of 1972, is
- 73 reenacted as follows:
- 74 69-43-7. (1) Any processor who fails to file a report or to
- 75 pay any assessment within the time required by the department
- 76 shall forfeit to the department a penalty of five percent (5%) of
- 77 the assessment determined to be due, plus one percent (1%) of such
- 78 amount for each month of delay or fraction thereof after the first
- 79 month after such report was required to be filed or such
- 80 assessment became due. The penalty shall be paid to the
- 81 department and shall be disposed of by it in the same manner as
- 82 funds derived from the payment of the assessment imposed herein.
- 83 (2) The department shall collect the penalties levied
- 84 herein, together with the delinquent assessment, by any or all of
- 85 the following methods:
- 86 (a) By voluntary payment by the person liable.
- 87 (b) By legal proceedings instituted in a court of
- 88 competent jurisdiction.
- 89 (3) Any person required to collect the assessment provided
- 90 for in this act who fails to remit the assessment or who refuses
- 91 to allow full inspection of the premises or such books, records or
- 92 other documents relating to the liability of such person for the
- 93 assessment herein imposed, or who shall hinder or in any delay or
- 94 prevent such inspection, shall be guilty of a misdemeanor and,
- 95 upon conviction, shall be punished by a fine not to exceed One
- 96 Thousand Dollars (\$1,000.00) or by imprisonment not to exceed one
- 97 (1) year, or both.
- 98 SECTION 5. Section 69-43-9, Mississippi Code of 1972, is

- 99 reenacted as follows:
- 100 69-43-9. (1) The Mississippi Ratite Council and Promotion
- 101 Board shall plan and conduct a program of research, education and
- 102 advertising designed to promote the ratite industry in
- 103 Mississippi. The board is authorized to use the funds derived
- 104 from the assessment imposed herein for these purposes, including
- 105 basic administration expenses of the plan. After paying
- 106 administrative expenses, all remaining funds shall be expended on
- 107 a pro rata basis of emus and ostriches processed or sold. Use of
- 108 these funds may be applied, as prescribed in this section, within
- 109 or without the State of Mississippi, including regional, national
- 110 and international research and promotional applications.
- 111 (2) The funds may be expended only for the purposes set out
- 112 in this act and shall be spent in no manner for political
- 113 purposes. A report of all expenditures shall be made annually
- 114 with three (3) copies of the report to be filed with each of the
- 115 following: The Clerk of the House of Representatives, the
- 116 Secretary of the Senate and the State Law Library.
- SECTION 6. Section 69-43-11, Mississippi Code of 1972, is
- 118 reenacted as follows:
- 119 69-43-11. The State Tax Commission shall provide any
- 120 information necessary to assist the Department of Agriculture and
- 121 Commerce in collecting the assessments provided for in this
- 122 chapter.
- SECTION 7. Section 69-43-13, Mississippi Code of 1972, is
- 124 amended as follows:
- 125 69-43-13. Sections 69-43-1 through 69-43-11, shall stand
- 126 repealed on July 1, <u>2004</u>.
- 127 SECTION 8. This act shall take effect and be in force from
- 128 and after July 1, 2000.
