## COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 904

AN ACT TO AMEND SECTION 35-1-21, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE STATE VETERANS AFFAIRS BOARD SHALL BE SOLELY 3 RESPONSIBLE FOR THE OPERATION AND MAINTENANCE OF THE STATE VETERANS HOME LOCATED IN COLLINS, MISSISSIPPI, AND SHALL NOT 5 CONTRACT FOR MANAGEMENT PURPOSES WITH ANY NONGOVERNMENTAL ENTITY OR THE UNITED STATES DEPARTMENT OF VETERANS AFFAIRS TO OPERATE THE HOME; TO PROVIDE THAT THE STATE DEPARTMENT OF HEALTH SHALL CONDUCT 6 7 CERTAIN CERTIFICATION SURVEYS AT THE STATE VETERANS HOME; AND FOR 8 RELATED PURPOSES. 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 35-1-21, Mississippi Code of 1972, is 11 amended as follows:[JMR1] 12 35-1-21. (1) Upon the establishment of the Mississippi 13 State Veterans Home, and any additional homes as may be 14 15 established, the Mississippi State Veterans Affairs Board is 16 hereby designated as the governing authority of any such facilities. The operation and maintenance of all veterans homes 17 shall meet the standards of the United States Department of 18 Veterans Affairs with regard to the operation of state veterans 19 homes.

(2) The State Veterans Affairs Board may contract with 21 nongovernmental entities or the United States Department of 22 23 Veterans Affairs to operate state veterans homes. The board may contract with the vendor whose proposal is most advantageous to 24 25 the state and veterans, taking into consideration cost factors, program suitability factors, management plan, delivery of care and 26 service to residents, excellence of program design, key personnel, 27

- corporate or company resources, financial condition of the vendor, 28
- 29 corporate experience and past performance, and any other

requirements deemed necessary by the board and expressed in its solicitation for proposals. Contract(s) awarded under this section may be for periods exceeding one (1) year. The board is not required to select the vendor offering the lowest cost
```

- 34 proposal but shall select the vendor who, in the board's
- 35 discretion, offers the proposal most advantageous to the State of
- 36 Mississippi and veterans. When any contract is awarded, the
- 37 reason(s) for the awarding of the contract shall be entered on the
- 38 minutes of the board. The provisions of this paragraph shall
- 39 supersede any rule or regulation of the State Personnel Board to
- 40 the contrary.
- 41 (3) The State Veterans Affairs Board may, as permitted by
- 42 federal laws or regulations, purchase from the United States
- 43 Department of Veterans Affairs, from contracts established by the
- 44 United States Department of Veterans Affairs, or through other
- 45 sharing agreements between the board and the United States
- 46 Department of Veterans Affairs, services, commodities, supplies
- 47 and equipment for use in operation of, and provision of care to
- 48 residents of, the state veterans homes when such purchases or
- 49 agreements are advantageous to the veterans and the state.
- 50 (4) Beginning July, 1, 2000, the State Veterans Affairs
- 51 Board shall be solely responsible for the operation and
- 52 <u>maintenance of the state veterans home located in Collins,</u>
- 53 <u>Mississippi</u>, and shall not contract for management purposes with
- 54 any nongovernmental entity or the United States Department of
- 55 <u>Veterans Affairs to operate the home</u>. The State Veterans Affairs
- 56 Board shall hire the administrator and all other personnel for the
- 57 <u>veterans home</u>. The mission of the State Veterans Affairs Board in
- 58 managing the Collins, Mississippi, facility shall be to provide
- 59 <u>domiciliary care and other related services for eligible veterans</u>
- in the most cost efficient manner. On or before January 1, 2002,
- 61 the State Veterans Affairs Board shall file a report with the
- 62 <u>Chairman of the Senate Veterans and Military Affairs Committee and</u>
- 63 the Chairman of the House Military Affairs Committee specifying
- 64 its recommendations on whether to continue to manage the Collins,
- 65 <u>Mississippi, home or to contract with a nongovernmental entity to</u>
- 66 operate the home. This subsection shall stand repealed from and

- 67 <u>after July 1, 2002.</u>
- 68 (5) The State Department of Health shall perform an initial
- 69 <u>certification survey of the State Veterans Home in Collins,</u>
- 70 Mississippi, on or about July 1, 2000. The purpose of this
- 71 <u>initial survey is to provide a baseline for measuring the quality</u>
- 72 of care during the period for which this section applies.
- 73 <u>In addition to the initial certification survey, the State</u>
- 74 Department of Health shall, as appropriate and in its discretion,
- 75 <u>conduct periodic follow-up certification surveys, during the</u>
- 76 period for which this section applies, of the State Veterans Home
- 77 <u>in Collins, Mississippi.</u>
- 78 SECTION 2. This act shall take effect and be in force from
- 79 and after July 1, 2000.
