10	SECTION 1. Section 75-76-129, Mississippi Code of 1972, is

12	75-76-129. On or before the last day of each month all
13	taxes, fees, interest, penalties, damages, fines or other monies
14	collected by the State Tax Commission during that month under the
15	provisions of this chapter, with the exception of (a) the local
16	government fees imposed under Section 75-76-195, and (b) an amount
17	equal to Four Million One Hundred Sixty-seven Thousand Dollars
18	(\$4,167,000.00), of the revenue collected pursuant to the fee
