HOUSE BILL NO. 1395

1 AN ACT TO AMEND SECTION 89-3-7, MISSISSIPPI CODE OF 1972, TO
2 PROVIDE FORMS OF ACKNOWLEDGMENTS FOR CORPORATE GENERAL PARTNERS OF
3 PARTNERSHIPS AND CORPORATE MEMBERS AND MANAGERS OF LIMITED
4 LIABILITY COMPANIES; AND FOR RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 SECTION 1. Section 89-3-7, Mississippi Code of 1972, is
7 amended as follows:

8 89-3-7. The following forms of acknowledgment may be used in
9 the case of conveyances or other written instruments affecting
10 real estate or personal property; and any acknowledgment so taken
11 and certified shall be sufficient to satisfy all requirements of
12 law:
