6	SECTION 1. The following sum, or so much of it as may be
7	necessary, is appropriated out of any money in the State General
8	Fund not otherwise appropriated, to the State Department of
9	Education for the Minimum Education Program for the purpose of
10	defraying the expense of increasing the salaries of teachers and
11	assistant teachers for the fiscal year beginning July 1, 2000, and
12	ending June 30, 2001\$110,000,000.00.
13	SECTION 2. The money appropriated by Section 1 of this act
14	is for the purpose of funding the increase in the annual salaries
15	of teachers prescribed in Section 37-19-7, Mississippi Code of
