- 3 WHEREAS, Reverend Richard G. Burns, a great servant of God,
- 4 has retired as pastor of New Mt. Elem Missionary Baptist Church
- 5 after 32 years of dedicated service; and
- 6 WHEREAS, Reverend Burns, son of the late Bertha Anderson
- 7 Burns and the late Alexander Judge Burns, was born on February 28,
- 8 1908, in Vicksburg, Mississippi; and
- 9 WHEREAS, Reverend Burns received his education from the
- 10 Warren County Public Schools and graduated from the Mississippi
- 11 Baptist Seminary, where he earned a bachelor of theology and a
- 12 master's in theological studies; and
- 13 WHEREAS, Reverend Burns accepted God's call to the ministry
- 14 and was ordained as a minister in December 1945; and
- WHEREAS, in 1951, Reverend Burns was elected as the pastor of
- 16 Revelation Baptist Church and pastor of Mt. Elem Baptist Church in
- 17 1968; and
- 18 WHEREAS, during his tenure at Mt. Elem Baptist Church,
- 19 Reverend Burns worked tirelessly to ensure the construction of a
- 20 new worship building, which is now known as New Mt. Elem
- 21 Missionary Baptist Church; and
- 22 WHEREAS, Reverend Burns, at 91 years old, is still an active
- 23 and vital member of his community, serving as Moderator of the
- 24 Warren County District Association, Worshipful Master of St.
- 25 Peter's Lodge #5, Secretary of Overcome Lodge #1, Patron of St.
- 26 Mary's Chapter #2 of the Order of the Eastern Star, Grand

- 27 Secretary of the M.W. Successful Grand Lodge A.F. and A.M., Board
- 28 Member of Parkview Regional Home Health, former President of the
- 29 Warren County Sunday School Institute and Convention, a founding
- 30 Board Member and former Secretary of the Vicksburg Center of the
- 31 Mississippi Baptist Seminary, former recording Secretary of the
- 32 Warren County Baptist Association, former board member of the YMCA
- 33 and former board member of the Fisher Ferry Water Club; and
- 34 WHEREAS, in addition, Reverend Burns has participated in the
- 35 General Missionary Baptist State Convention of Mississippi and the
- 36 National Baptist Convention, the Vicksburg's Minister's Alliance
- 37 and served on the Advisory Council for the Mississippi Action for
- 38 Progress/Head Start Program; and
- 39 WHEREAS, Reverend Burns has been lovingly supported in all
- 40 his endeavors by his late wife, Estella Parson Burns, their nine
- 41 children, 36 grandchildren, 50 great-grandchildren and 5
- 42 great-great-grandchildren; and
- WHEREAS, it is the policy of this Legislature to recognize
- 44 and commend outstanding Mississippians such as Reverend Burns, who
- 45 has dedicated his career to ministering to the people in his
- 46 community:

- 49 THEREIN, That we do hereby commend and congratulate Reverend
