- 6 WHEREAS, after graduating from Vardaman High School, Mr.
- 7 Carter attended Delta State University in Cleveland, Mississippi,
- 8 where he earned a bachelor's degree in business administration;

- 10 WHEREAS, Mr. Carter furthered his education at Mississippi
- 11 College, where he earned a master's in business administration and
- 12 earned a juris doctorate from Mississippi College School of Law;
- 13 and
- 14 WHEREAS, Mr. Carter, a graduate of the Marine Corps Officer's
- 15 Candidate School in Quantico, Virginia, served in the United
- 16 States Marine Corps from March 1969 until 1972, when he was
- 17 released from active duty with the rank of First Lieutenant; and
- 18 WHEREAS, in 1972, Mr. Carter was hired as the Personnel
- 19 Officer for the City of Jackson, where he worked extensively in
- 20 bringing the City of Jackson into compliance with the 1975 Consent
- 21 Decree; and
- 22 WHEREAS, Mr. Carter began his service to the State of
- 23 Mississippi in 1972, serving as the Assistant Executive Secretary
- 24 to the Mississippi State Public Service Commission and served
- 25 briefly as an Administrative Assistant for the Mississippi State
- 26 Treasury Department in 1981; and

- 27 WHEREAS, in 1981, Mr. Carter began working for the Office of
- 28 the Attorney General of the State of Mississippi as a Special
- 29 Assistant Attorney General and has also served as an Assistant
- 30 Attorney General from 1989 to 1996; and
- 31 WHEREAS, in 1986, Mr. Carter went to work as the Director of
- 32 Elections for the Office of the Secretary of State and served as
- 33 Assistant Secretary of State for Elections from 1996 to January
- 34 2000; and
- 35 WHEREAS, currently, Mr. Carter is serving the State of
- 36 Mississippi as a Special Assistant Attorney General; and
- 37 WHEREAS, it is the policy of this Legislature to recognize
- 38 and commend outstanding Mississippians such as Mr. Phil Carter,
