COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2111

AN ACT TO ESTABLISH A TASK FORCE ON GANG BEHAVIOR IN
MISSISSIPPI TO COORDINATE THE EFFORTS OF LAW ENFORCEMENT AGENCIES
TO STUDY, TRACK, IDENTIFY AND DEVELOP STRATEGIES FOR DEALING WITH
GANGS AND DEVIANT GROUPS; TO PROVIDE FOR THE APPOINTMENT OF
MEMBERS TO THE TASK FORCE AND SPECIFY THE RESPONSIBILITIES OF THE
TASK FORCE; TO PROVIDE FOR THE ADMINISTRATIVE SUPPORT OF THE TASK
FORCE UNDER THE MISSISSIPPI DEPARTMENT OF PUBLIC SAFETY; AND FOR
RELATED PURPOSES.

- 9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 10 <u>SECTION 1.</u> (1) There is created the Task Force on Gang
- 11 Behavior in Mississippi, the purpose of which is to coordinate the
- 12 efforts of law enforcement agencies in the state to study, track,
- 13 identify and develop strategies for dealing with gangs and deviant
- 14 groups and individuals.
- 15 (2) The task force shall be composed of the following voting
- 16 members: the Director of the Bureau of Narcotics, or his
- 17 designee; the Commissioner of Public Safety, or his designee; the
- 18 chief drug investigator for the Mississippi Department of
- 19 Corrections; the Attorney General, or his designee; the State
- 20 Superintendent of Education, or his designee; the President of the
- 21 Mississippi Sheriffs' Association, or his designee; the President
- 22 of the Mississippi Association of Chiefs of Police, or his
- 23 designee; the President of the Mississippi Constables'
- 24 Association, or his designee; the Adjutant General of the
- 25 Mississippi National Guard, or his designee; the Director of the
- 26 Office of Youth Services of the Department of Human Services, or
- 27 his designee; a designee of the Mississippi Chapter of the
- 28 National Organization of Black Law Enforcement; a designee of the
- 29 National Association for the Advancement of Colored People; an

- 30 appointee of the Speaker of the House and an appointee of the
- 31 Lieutenant Governor, both of whom shall be chosen from experts in
- 32 criminal justice and gang activity, and who shall serve as co-vice
- 33 chairmen of the task force; and an appointee of the Governor who
- 34 is an expert in criminal justice and gang activity, who shall
- 35 serve as chairman of the task force.
- 36 (3) The Chairmen of the Senate and House Committees on
- 37 Juvenile Justice, Judiciary (Judiciary En Banc), Corrections and
- 38 Education, or their designees, shall serve in an advisory capacity
- 39 as ex officio nonvoting members of the task force.
- 40 (4) The Chairman of the Task Force on Gang Behavior shall be
- 41 appointed annually by the Governor, who shall call the initial
- 42 meeting of the task force. The task force shall adopt bylaws and
- 43 rules for its efficient operation, which may include designation
- 44 of its organizational structure including other officers and
- 45 committees, duties of committees, staff policies and other such
- 46 procedures as may be necessary.
- 47 (5) The task force shall be assigned to the Mississippi
- 48 Department of Public Safety for administrative purposes only, and
- 49 the department shall designate staff to assist the task force.
- 50 The task force shall have a line item in the budget of the
- 51 Department of Public Safety, shall be financed through the
- 52 department's annual appropriation wherein funds are made available
- 53 and shall be subject to Department of Public Safety policies and
- 54 procedures. Members of the task force may receive, within the
- 55 funds appropriated, reimbursement for travel expenses incurred
- 56 while engaged in official business of the task force, except that
- 57 the legislative members shall be paid from the contingent expense
- 58 funds of their respective houses.
- 59 (6) The task force shall meet and conduct business at least
- 60 quarterly. All meetings of the task force and any committees of
- 61 the task force shall be open to the public, with opportunities for
- 62 public comment.
- (7) The task force may apply for and expend grants or other
- 64 contributions for the purpose of studying and tracking gang and
- 65 deviant activity in Mississippi.
- 66 (8) The Task Force on Gang Behavior in Mississippi shall

- 67 have the following responsibilities:
- 68 (a) Serve as a liaison with the appropriate local law
- 69 enforcement agencies, public school officials, human services
- 70 officials, youth court personnel and correctional officials to
- 71 track, study, identify and develop strategies for the prevention,
- 72 identification and suppression of illegal gang and deviant groups.
- 73 (b) Serve an advocacy and public awareness role with
- 74 the general public regarding illegal gang and deviant group
- 75 behavior.
- 76 (c) Recommend and make annual reports to the
- 77 Legislature and Governor regarding appropriate policies to reduce
- 78 illegal and deviant gang activity in Mississippi.
- 79 (d) Consult with experts and examine actions taken in
- 80 other states regarding illegal gang activity.
- 81 SECTION 2. This act shall take effect and be in force from
- 82 and after July 1, 2000, subject to the availability of funds
- 83 specifically appropriated therefor by the Legislature during the
- 84 2000 Regular Session or any subsequent session. It is the intent
- 85 of the Legislature that this act shall not take effect until the
- 86 Legislature has funded the implementation thereof by line item
- 87 appropriation as certified to the Secretary of State by the
- 88 Legislative Budget Office.
