SENATE BILL NO. 2891

1 AN ACT TO AMEND SECTION 49-7-31, MISSISSIPPI CODE OF 1972, TO
2 REQUIRE DEER SEASON TO BE ESTABLISHED BY ZONES AND TO SET THE END
3 OF THE SEASON FOR THE SOUTHERN ZONE; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. Section 49-7-31, Mississippi Code of 1972, is
6 amended as follows:[LTR1]

7 49-7-31. (1) The open season for game birds and game
8 animals shall be as follows:

9 (a) On bobwhite quail: The season shall open on
10 Thanksgiving day and run through the first Saturday in March next
11 following.

12 (b) On pheasant: There shall be no open season on
13 pheasant.

14 (c) On wild turkey: The commission shall fix the
15 spring season between the Saturday nearest March 20 and May 1 in
16 designated areas. In addition, the commission may fix special
17 fall either-sex seasons.

18 (d) On squirrel:

19 (i) Zone 1: For areas north of Highway 82 plus
20 those portions of Sunflower County and Washington County south of
21 Highway 82 the season shall open on the Saturday nearest October 1
22 and run through February 28.

23 (ii) Zone 2: For areas between Highway 82 and
24 Highway 84, plus such portions of the state south of Highway 84
25 and west of Interstate 55, the season shall open on the Saturday
26 nearest October 15 and run through February 28.

27 (iii) Zone 3: For areas south of Highway 84 and
28 east of Interstate 55 the season shall open on the last Saturday
29 in October and run through February 28.

30 (e) On deer:

31 (i) With bow and arrow: October 1 through the
32 Friday prior to Thanksgiving.

33 (ii) With guns and with dog: From the Saturday
34 prior to Thanksgiving through December 1.

35 (iii) With primitive weapons and without dogs:
36 December 2 through December 15.

37 (iv) With guns and without dogs: December 16
38 through December 23. The commission shall set the season by zones
39 in the state, with the season in the southern zone ending on
40 January 31. However, the commission may allow hunting statewide
41 or in specific areas with any legal weapon which it may designate
42 without dogs after the end of the last season for hunting deer
43 with guns and with dogs, but the season with legal designated
44 weapons and without dogs shall not extend beyond January 31.

45 (v) With guns and with dogs: December 24 through
46 a date fixed by the commission that will provide a total of
47 thirty-nine (39) days of hunting deer with guns and with dogs when
48 added to the number of days provided for hunting deer with guns
49 and with dogs in paragraph (e)(ii).

50 (vi) When hunting deer during any gun season on
51 deer, a hunter must wear in full view five hundred (500) square
52 inches of solid unbroken fluorescent orange.

53 (vii) In order to set and regulate the deer
54 seasons, the commission may:

55 A. Set and regulate the deer seasons on
56 wildlife management areas which it administers;

57 B. Allow the harvesting of antlerless deer in
58 the districts or zones upon the recommendation of the executive
59 director based upon good and substantial quantitative data and

60 research evaluations that demonstrate that the harvesting is
61 necessary to properly manage the herd. The commission, only upon
62 the recommendation of the executive director, may allow the
63 harvesting of antlerless deer during the deer season with guns and
64 with dogs by a majority vote of the commission. Nothing in this
65 section prohibits the harvesting of either sex deer by landowners
66 or leaseholders on private lands under a deer management program
67 prescribed or approved by the executive director.

68 C. Provide a special permit for the
69 harvesting of deer when they are depredating and destroying crops.
70 The department shall supervise the harvesting and provide for the
71 salvaging of the meat of the animals. The commission may
72 authorize the department to assist any farmer in this state, who
73 sustains crop damage by wildlife, in eradication of the problem
74 wildlife.

75 (viii) The commission shall establish a special
76 hunting season for youth under the age of sixteen (16) and for
77 handicapped persons in the Natchez State Park. The commission
78 shall also establish a primitive weapon season in the Natchez
79 State Park. The selection of participants in the primitive weapon
80 season shall be by public drawing from all qualified applications.
81 The commission shall set the number of permits to be issued and
82 the length of the special seasons. The commission may also
83 establish a special hunting season for youth and handicapped
84 persons or a primitive weapon season as provided in this
85 subparagraph in any other state park under the jurisdiction of the
86 department but shall only do so upon the recommendation of the
87 staff of the department as approved by the commission. The
88 commission shall select participants and set the number of permits
89 to be issued and the length of the special seasons in the manner
90 provided in this subparagraph.

91 (ix) The commission may establish and regulate
92 special youth hunts for all nonmigratory game birds and animals

93 outside of the open season on wildlife management areas and on
94 private lands.

95 (f) On fur-bearing animals: The commission may fix the
96 open season on fur-bearing animals between November 1 and March 1
97 next following and fix the open season for hunting opossums,
98 raccoons and bobcats with dogs and guns by licensed hunters from
99 October 1 to February 28 next following; but raccoons and bobcats
100 may be run, hunted, chased or pursued throughout the year with
101 dogs by licensed hunters. The commission may establish an
102 additional open season on raccoon from July 1 through October 1,
103 and the bag limit on raccoon during the additional open season
104 shall be one (1) per party, per night.

105 (g) On rabbits: The season shall open on the Saturday
106 nearest October 15 and run through February 28 next following, and
107 when rabbits are depredating or destroying crops, the owner of the
108 crops or his tenants may shoot the rabbits with guns.

109 (h) On predatory animals: The hunting of predatory
110 animals shall be restricted to the open seasons for hunting any
111 game animal or game bird, using only the firearms, ammunition,
112 primitive weapons or archery equipment legal for use during that
113 open season. Landowners, agricultural leaseholders or their
114 designated agents may take predatory animals year-round on lands
115 owned or leased by them. The taking of any animal or animals
116 other than beavers or coyote by the use of a trap or traps is
117 unlawful except during the time the season is open for the taking
118 of fur-bearing animals. Fox and coyote may be run, chased or
119 pursued with dogs except as provided in Section 49-7-32 year-round
120 by licensed hunters.

121 (i) On migratory birds: The open season for migratory
122 birds shall be the season prescribed by the Federal Migratory Bird
123 Treaty regulations.

124 (j) On nongame gross fish: The season for taking
125 nongame gross fish by hand or with grappling tongs shall be from

126 May 1 to July 15.

127 (k) It is unlawful to trap fox after the closed season
128 for trapping of other fur-bearing animals, except on property
129 owned or leased by the person trapping.

130 (2) It is the intent of the Legislature that the open season
131 for game birds and game animals shall be stabilized unless some
132 unforeseen calamity affecting the resource necessitates earlier
133 change.

134 SECTION 2. This act shall take effect and be in force from
135 and after July 1, 2000.
