1 2 3 4	AN ACT TO AMEND SECTION 37-22-3, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT SECOND LEVEL FUNDING PROGRAM FUNDS IN ADDITION TO MINIMUM EDUCATION PROGRAM FUNDS ARE AVAILABLE TO NEWLY ESTABLISHED REGIONAL HIGH SCHOOL CENTERS; AND FOR RELATED PURPOSES.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
6	SECTION 1. Section 37-22-3, Mississippi Code of 1972, is
7	amended as follows:[RDD1]
8	37-22-3. There is herein provided a Second Level Funding
9	Program which shall qualify any school district within a county
10	wherein there is only one (1) school district located for
11	additional state funding on an annual basis. The nonparticipation
12	of any line consolidated school district to conform their district
13	administration to receive second level funding under the
14	provisions of this section shall not prohibit the participation of
15	any other school districts located within any of the affected
16	counties in such funding program. In the event the board of
17	trustees of a line consolidated school district elects to
18	participate in second level funding, it shall merge its
19	administration with the county in which the majority of its
20	facilities are located. The State Board of Education shall
21	designate the county in which the majority of such line
22	consolidated district facilities are located in accordance with
23	its established inventory of school district facilities. The
24	school boards in any such county having only one (1) school
25	district on July 1, 1989, and the school boards in any county
26	having more than one (1) school district which hereafter adopts a
27	plan for the transition of all administrative functions into one

- 28 (1) school district for such county, shall qualify for this Second
- 29 Level Funding Program. Any uniform millage assistance grant
- 30 received by an agricultural high school shall not affect the
- 31 granting of second level funding grants to any school district
- 32 under the provisions of this section; and any agricultural high
- 33 school located in such school district shall also be eligible for
- 34 such second level funding grants. The state funds available to
- 35 such school district for the Second Level Funding Program shall be
- 36 Thirty-six Dollars (\$36.00) per pupil in average daily attendance.
- 37 The total state funds needed for the Second Level Funding Program
- 38 annually shall be the total of the amounts needed by all of the
- 39 school districts in the state having one (1) school district
- 40 within the county. Second Level Funding Program funds shall also
- 41 be available to any two (2) or more school districts within a
- 42 <u>county which after January 1, 2000, jointly establish a regional</u>
- 43 <u>high school center pursuant to Section 37-7-417, Mississippi Code</u>
- 44 of 1972. In order to qualify for additional state funds under
- 45 this provision, the newly established regional high school shall
- 46 be the only high school in operation in the county. The State
- 47 Second Level Funding Program Fund is hereby established in the
- 48 State Treasury which shall be used to distribute the funds to
- 49 school districts entitled under the provisions of this section.
- 50 Any such funds shall be transferred to the school district
- 51 maintenance fund of such district in the manner prescribed in
- 52 Section 37-19-47, Mississippi Code of 1972, and shall be expended
- 53 in the manner provided by law for classroom instructional
- 54 purposes.
- 55 SECTION 2. This act shall take effect and be in force from
- 56 and after July 1, 2000.
