SENATE BILL NO. 3269
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION FOR THE SUPPORT AND
2 MAINTENANCE OF THE ALCORN STATE UNIVERSITY AGRICULTURAL PROGRAMS
3 FOR FISCAL YEAR 2001.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 SECTION 1. The following sum, or so much thereof as may be
6 necessary, is hereby appropriated out of any money in the State
7 General Fund not otherwise appropriated, for the support and
8 maintenance of the Alcorn State University Agricultural Programs
9 for the fiscal year beginning July 1, 2000, and ending
10 June 30, 2001.....\$ 5,468,257.00.

11 SECTION 2. The following sum, or so much thereof as may be
12 necessary, is hereby authorized for expenditure out of any special
13 source funds which are collected by or otherwise become available,
14 for the support and maintenance of the Alcorn State University
15 Agricultural Programs for the fiscal year beginning July 1, 2000,
16 and ending June 30, 2001.....\$ 1,523,755.00.

17 SECTION 3. Of the funds appropriated in Section 2, the
18 following amounts shall be derived from the Education Enhancement
19 Fund as follows:

20 (a) Twenty-two Thousand Two Hundred Seven Dollars
21 (\$22,207.00) shall be derived from funds deposited
22 pursuant to Sections 27-65-75 and 27-67-31, Mississippi
23 Code of 1972.

24 (b) One Million Fifty-one Thousand Five Hundred
25 Forty-eight Dollars (\$1,051,548.00) shall be
26 derived from funds deposited pursuant to

27 Section 27-103-203(1), Mississippi Code of 1972.

28 SECTION 4. No general funds authorized to be expended herein
29 shall be used to replace federal funds and/or other special funds
30 which are being used for salaries which are withdrawn and no
31 longer available.

32 SECTION 5. It is the intention of the Legislature that the
33 agency's budget request for Fiscal Year 2002 shall be submitted to
34 the Joint Legislative Budget Committee in a format and level of
35 detail comparable to the format and level of detail provided
36 during the Fiscal Year 2001 budget request process.

37 SECTION 6. Should revenues generated and deposited to the
38 Education Enhancement Fund pursuant to Section 27-103-203(1),
39 Mississippi Code of 1972, fall below funds appropriated herein
40 from said source, the Board of Trustees of State Institutions of
41 Higher Learning shall notify the Department of Finance and
42 Administration as to which allotments shall be reduced to insure
43 that expenditures do not exceed actual revenues.

44 SECTION 7. It is the intention of the Legislature that of
45 the funds appropriated under the provisions of this act, the
46 amount of Two Hundred Thousand Dollars (\$200,000.00) shall be
47 allocated to defray the cost of a Sweet Potato program in Bolivar
48 County.

49 SECTION 8. It is the intention of the Legislature that of
50 the funds appropriated under the provisions of this act, Six
51 Hundred Thousand Dollars (\$600,000.00) shall be allocated to
52 initiate the operations of the Alcorn State University -
53 Agribusiness and Natural Resources Development Center.

54 SECTION 9. The money herein appropriated shall be paid by
55 the State Treasurer out of any money in the State Treasury to the
56 credit of the proper fund or funds as set forth in this act, upon
57 warrants issued by the State Fiscal Officer; and the State Fiscal
58 Officer shall issue his warrants upon requisitions signed by the
59 proper person, officer or officers in the manner provided by law.

60 SECTION 10. This act shall take effect and be in force from
61 and after July 1, 2000.
