8	Governor's Initiative for Volunteer Excellence (GIVE) Program; and
9	WHEREAS, she will be honored at the awards luncheon on May 4,
10	2000, in Jackson, Mississippi, where all program recipients and
11	nominators will be recognized; and
12	WHEREAS, Bobbi Barrows is a literacy volunteer who has
13	overcome her own reading difficulties and now helps children and
14	adults become better readers; as part of a partnership with
15	AmeriCorps, the Mississippi Department of Education and the
16	Parenting Resource Center in Picayune, she is helping children
17	with severe reading problems to improve their grades, adults to
18	raise their reading levels, and parents to find ways to use
19	reading and writing at home with their children; and
20	WHEREAS, as a child growing up, her greatest obstacle was
21	learning to read; she struggled all of her academic career with
22	reading; she eventually graduated from high school, but to do so
23	she had to work diligently and use compensatory techniques; after
24	graduation she continued her struggle, she married and her husband
25	helped and encouraged her to read high interest material aloud to
26	him; when she became a mother, she knew the value of reading aloud

         WHEREAS, as part of a partnership with AmeriCorps, the

    Mississippi Department of Education and the Parenting Resource

    Center in Picayune, Mississippi, Ms. Barrows works Monday through
    Friday, serving 32 children at Nicholson Elementary School who

    have severe reading, writing and spelling difficulties; she works
    in five classes in a Title I Program for dyslexic children, she
33
    helps the children with one-on-one and small group tutoring; her
34
    efforts have had a positive impact in her classes. The grades of

    the children she works with have improved dramatically, and the

    children have moved up into higher level workbooks; teachers have
    written letters about their successes. All of the children have

    been pre-tested for participation in the program, and they will be

    post-tested at the end of the program; and
         WHEREAS, in addition to her work during the school day, Ms.
41
    Barrows provides support to children as an after-school tutor;

    moreover, as part of her AmeriCorps service hours, she volunteers

    at the Parenting Resource Center each Monday and Wednesday from

    4:00-6:00 p.m. She helps parents who come to the center by
    serving as a resource for ways they can use reading and writing at

    home to help their children become better readers. Without her

    volunteer efforts the center would not be able to remain open
    during these extended hours. This center serves the entire

         WHEREAS, since November 1, 1999, Bobbi has also initiated a
    literacy class for eight adults and she volunteers as the

    facilitator of the Project H.O.P.E. Program for people who face

    reading challenges, not unlike her own, using the Texas Scottish
    Rite Hospital Literacy Program, a multi-sensory, intensive,

    systematic language-based approach to teaching reading, writing
