**AMENDMENT No. 1 PROPOSED TO**

**Senate Bill NO. 2621**

5       Amend by striking all after the enacting clause and inserting  
6 in lieu thereof the following:

8       SECTION 1. Section 19-11-7, Mississippi Code of 1972, is  
9 amended as follows:

10       [With regard to any county which is exempt from the  
11 provisions of Section 19-2-3, this section shall read as follows:]

12       19-11-7. The board of supervisors of each county of the  
13 State of Mississippi shall, at its August meeting of each year,  
14 prepare a complete budget of revenues, expenses and a working cash  
15 balance estimated for the next fiscal year, which shall be based  
16 on the aggregate funds estimated to be available for the ensuing  
17 fiscal year for each fund, from which such estimated expenses will  
18 be paid, exclusive of school maintenance funds, which shall be  
19 shown separately. Such statement of revenues shall show every  
20 source of revenue along with the amount derived from each source.  
21 The budget containing such statement of revenues and expenses  
22 shall be published at least one (1) time during August or  
23 September but not later than September 30 of the year in a  
24 newspaper published in the county, or if no newspaper is published  
25 therein, then in a newspaper having a general circulation therein.

26       [With regard to any county which is required to operate on a  
27 countywide system of road administration as described in Section

2819-2-3, this section shall read as follows:]

29 19-11-7. The county administrator of each county of the  
30 State of Mississippi shall prepare and submit to the board of  
31 supervisors at its August meeting of each year a complete budget  
32 of revenues, expenses and a working cash balance estimated for the  
33 next fiscal year, which shall be based on the aggregate funds  
34 estimated to be available for the ensuing fiscal year for each  
35 fund, from which such estimated expenses will be paid, exclusive  
36 of school maintenance funds, which shall be shown separately and  
37 exclusive of the budget of the sheriff's department which shall be  
38 prepared by the sheriff. Such statement of revenues shall show  
39 every source of revenue along with the amount derived from each  
40 source. The budget, including the sheriff's budget, containing  
41 such statement of revenues and expenses shall be published at  
42 least one (1) time during August or September but not later than  
43 September 30 of the year in a newspaper published in the county,  
44 or if no newspaper is published therein, then in a newspaper  
45 having a general circulation therein.

46 SECTION 2. This act shall take effect and be in force from  
47 and after July 1, 2000.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**
