6 Amend by striking all after the enacting clause and inserting  
7 in lieu thereof the following:

9 SECTION 1. The following sum, or so much thereof as may be  
10 necessary, is hereby appropriated out of any money in the State  
11 General Fund not otherwise appropriated, for expenses of the  
12 Executive Department, being the Governor's office and staff, for  
13 the fiscal year beginning July 1, 2000, and ending June 30, 2001,  
14 .....\$ 2,344,969.00.

15 SECTION 2. With the funds appropriated under the provisions  
16 of Section 1, the following positions are authorized:

22 Any escalations shall be made in accordance with the terms,  
23 conditions, and procedures established by law.

24 No general funds authorized to be expended herein shall be  
25 used to replace federal funds and/or other special funds which are  
26 being used for salaries authorized under the provisions of this  
27 act and which are withdrawn and no longer available.

28 SECTION 3. The following sum, or so much thereof as may be

29necessary, is hereby appropriated out of any money in the State  
30General Fund not otherwise appropriated, for expenses incidental  
31to the proper operation of the Governor's Mansion and residence of  
32the Governor for the fiscal year beginning July 1, 2000, and  
33ending June 30, 2001.....\$ 566,043.00.

34 SECTION 4. With the funds appropriated under the provisions  
35of Section 3, the following positions are authorized:

41 Any escalations shall be made in accordance with the terms,  
42conditions, and procedures established by law.

43 No general funds authorized to be expended herein shall be  
44used to replace federal funds and/or other special funds which are  
45being used for salaries authorized under the provisions of this  
46act and which are withdrawn and no longer available.

47 SECTION 5. The money herein appropriated shall be paid by  
48the State Treasurer out of any money in the State Treasury to the  
49credit of the proper fund or funds as set forth in this act, upon  
50warrants issued by the State Fiscal Officer; and the State Fiscal  
51Officer shall issue his warrants upon requisitions signed by the  
52proper person, officer or officers in the manner provided by law.

53 SECTION 6. This act shall take effect and be in force from  
54and after July 1, 2000.
