AMENDMENT No. 1 PROPOSED TO

House Bill NO. 365

7 **Amend by striking all after the enacting clause and inserting**
8 **in lieu thereof the following:**

10 SECTION 1. Section 19-11-7, Mississippi Code of 1972, is
11 amended as follows:

12 **[With regard to any county which is exempt from the**
13 **provisions of Section 19-2-3, this section shall read as follows:]**

14 19-11-7. The board of supervisors of each county of the
15 State of Mississippi shall, at its August meeting of each year,
16 prepare a complete budget of revenues, expenses and a working cash
17 balance estimated for the next fiscal year, which shall be based
18 on the aggregate funds estimated to be available for the ensuing
19 fiscal year for each fund, from which such estimated expenses will
20 be paid, exclusive of school maintenance funds, which shall be
21 shown separately. The statement of revenues shall show every
22 source of revenue along with the amount derived from each source.
23 The budget containing the statement of revenues and expenses shall
24 be published at least one (1) time during the month of August,
25 with such publication of the budget being at least three (3) days
26 before approval by the board, in a newspaper published in the
27 county, or if no newspaper is published therein, then in a
28 newspaper having a general circulation therein.

29 **[With regard to any county which is required to operate on a**

30 countywide system of road administration as described in Section
31 19-2-3, this section shall read as follows:]

32 19-11-7. The county administrator of each county of the
33 State of Mississippi shall prepare and submit to the board of
34 supervisors at its August meeting of each year a complete budget
35 of revenues, expenses and a working cash balance estimated for the
36 next fiscal year, which shall be based on the aggregate funds
37 estimated to be available for the ensuing fiscal year for each
38 fund, from which such estimated expenses will be paid, exclusive
39 of school maintenance funds, which shall be shown separately and
40 exclusive of the budget of the sheriff's department which shall be
41 prepared by the sheriff. The statement of revenues shall show
42 every source of revenue along with the amount derived from each
43 source. The budget, including the sheriff's budget, containing
44 the statement of revenues and expenses shall be published at least
45 one (1) time during the month of August, with such publication of
46 the budget being at least three (3) days before approval by the
47 board, in a newspaper published in the county, or if no newspaper
48 is published therein, then in a newspaper having a general
49 circulation therein.

50 SECTION 2. This act shall take effect and be in force from
51 and after July 1, 2000.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

1 AN ACT TO AMEND SECTION 19-11-7, MISSISSIPPI CODE OF 1972, TO
2 PROVIDE THAT THE ANNUAL BUDGET OF THE COUNTY SHALL BE PUBLISHED AT
3 LEAST ONE TIME DURING THE MONTH OF AUGUST, WITH SUCH PUBLICATION
4 BEING AT LEAST THREE DAYS BEFORE APPROVAL BY THE BOARD OF
5 SUPERVISORS; AND FOR RELATED PURPOSES.
