3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
4	SECTION 1. The following sum of money, or so much thereof as
5	may be necessary, is hereby appropriated out of any money in the
6	State General Fund not otherwise appropriated, to defray the
7	expenses of the office of the State Treasurer for the fiscal year
8	beginning July 1, 2001, and ending June 30, 2002
9	\$ 624,275.00.
10	SECTION 2. The following sum, or so much thereof as may be
11	necessary, is hereby appropriated out of any funds in the special
12	fund entitled Abandoned Property Fund in the State Treasury for
13	the purpose of defraying expenses of the State Treasurer in

15	certain other expenses of the office, for the fiscal year

No part of the funds appropriated herein shall be used in the payment of attorney's fees, nor shall any of said 132 funds be used either directly or indirectly, for the purpose of 133 paying any clerk, stenographer, assistant, deputy or other person 134 who may be related by blood or marriage within the third degree, 135 136 computed by the rules of the civil law, to the official employing or having the right of employment or selection thereof; and in the 137 138 event of any such payment, then the official or person approving and making or receiving such payment shall be jointly and 139 severally liable to return to the State of Mississippi and to pay 140 141 into the State Treasury three (3) times any such amount so paid or received, to be recovered at suit of the Attorney General; 142 143 provided that when the relationship is by affinity and the person through whom the relationship was established is dead, this 144 145 provision shall not apply. SECTION 13. The money herein appropriated shall be paid by 146 147 the State Treasurer out of any money in the State Treasury to the credit of the proper fund or funds as set forth in this act, upon 148 warrants issued by the State Fiscal Officer; and the State Fiscal 149 150 Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law. 151 152 SECTION 14. This act shall take effect and be in force from and after July 1, 2001. 153
