

REPORT OF CONFERENCE COMMITTEE

MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 2681: Commissioner of Public Safety; authorize to establish organizational structure for agency.

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.

2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

7 SECTION 1. Section 45-1-2, Mississippi Code of 1972, is
8 amended as follows:

9 45-1-2. (1) The Executive Director of the Department of
10 Public Safety shall be the Commissioner of Public Safety.

11 (2) The Commissioner of Public Safety shall establish the
12 organizational structure of the Department of Public Safety which
13 shall include the creation of any units necessary to implement the
14 duties assigned to the department and consistent with specific
15 requirements of law, including, but not limited to:

16 (a) Office of Public Safety Planning;

17 (b) Office of Medical Examiner;

18 (c) Office of Mississippi Highway Safety Patrol;

19 (d) Office of Crime Laboratories;

20 (e) Office of Law Enforcement Officers' Training
21 Academy;

22 (f) Office of Support Services.

23 (g) The Director of the Bureau of Narcotics created
24 under Section 41-29-107 shall establish the organizational
25 structure of the bureau.

26 (3) The department shall be headed by a commissioner who
27 shall be appointed by and serve at the pleasure of the Governor.
28 The appointment of the commissioner shall be made with the advice
29 and consent of the Senate. The commissioner may assign to the
30 appropriate offices such powers and duties as deemed appropriate
31 to carry out the department's lawful functions.

32 (4) The commissioner of the department shall appoint heads
33 of offices, who shall serve at the pleasure of the commissioner.
34 The commissioner shall have the authority to organize the offices
35 established by subsection (2) of this section as deemed
36 appropriate to carry out the responsibilities of the department.
37 The organization charts of the department shall be presented
38 annually with the budget request of the Governor for review by the
39 Legislature.

40 (5) The commissioner of the department shall appoint, from
41 within the Department of Public Safety, a statewide safety
42 training officer who shall serve at the pleasure of the
43 commissioner and whose duty it shall be to perform public training
44 for both law enforcement and private persons throughout the state
45 concerning proper emergency response to the mentally ill,
46 terroristic threats or acts, domestic conflict, other conflict
47 resolution, and such other matters as the commissioner may direct.

48 SECTION 2. This act shall take effect and be in force from
49 and after July 1, 2001.

**Further, amend by striking the title in its entirety and
inserting in lieu thereof the following:**

2 AUTHORIZE THE COMMISSIONER OF PUBLIC SAFETY TO ESTABLISH AN

3 ORGANIZATIONAL STRUCTURE FOR THE DEPARTMENT OF PUBLIC SAFETY TO
4 IMPLEMENT THE RESPONSIBILITIES OF THE DEPARTMENT; AND FOR RELATED
5 PURPOSES.
