AMENDMENT No. 1 PROPOSED TO**

**Senate Bill NO. 3055**

**By Representative(s) Committee**

**Amend by striking all after the enacting clause and inserting  
in lieu thereof the following:**

11           SECTION 1. In addition to all other sums heretofore  
12 appropriated, the following sum, or so much thereof as may be  
13 necessary, is hereby appropriated out of any money in the State  
14 Treasury to the credit of the Budget Contingency Fund created in  
15 Senate Bill No. 2680, 2001 Regular Session, for the support and  
16 maintenance of the Minimum Education Program, for the fiscal year  
17 ending June 30, 2001..... \$17,000,000.00.

18           With the funds herein appropriated, the State Department of  
19 Education may transfer an amount not to exceed Two Million Six  
20 Hundred One Thousand Three Hundred Thirty-eight Dollars  
21 (\$2,601,338.00) to the Board of Trustees of State Institutions of  
22 Higher Learning for the support and maintenance of the Critical  
23 Needs Teacher Scholarship Program.

24           SECTION 2. In addition to all other sums heretofore  
25 authorized, the following sum, or so much thereof as may be  
26 necessary, is hereby authorized for expenditure by the Board of  
27 Trustees of State Institutions of Higher Learning out of any money

28 available to support the Critical Needs Teacher Scholarship

29 Program for the fiscal year ending June 30, 2001.....  
30 ..... \$ 1,078,603.00.

31 SECTION 3. The money herein appropriated shall be paid by  
32 the State Treasurer out of any money in the proper fund or funds  
33 as set forth in this act, upon warrants issued by the State Fiscal  
34 Officer; and the State Fiscal Officer shall issue his warrants  
35 upon requisitions signed by the proper person, officer or  
36 officers, in the manner provided by law.

37 SECTION 4. This act shall take effect and be in force from  
38 and after its passage.

**Further, amend by striking the title in its entirety and  
inserting in lieu thereof the following:**

1 AN ACT MAKING AN ADDITIONAL APPROPRIATION OF SPECIAL FUNDS TO  
2 THE STATE DEPARTMENT OF EDUCATION FOR THE PURPOSE OF FULLY FUNDING  
3 THE MINIMUM EDUCATION PROGRAM; TO PROVIDE AUTHORITY FOR THE STATE  
4 DEPARTMENT OF EDUCATION TO TRANSFER FUNDS TO THE BOARD OF TRUSTEES  
5 OF STATE INSTITUTIONS OF HIGHER LEARNING FOR THE SUPPORT AND  
6 MAINTENANCE OF THE CRITICAL NEEDS TEACHER SCHOLARSHIP PROGRAM; AND  
7 TO PROVIDE ADDITIONAL SPENDING AUTHORITY TO THE BOARD OF TRUSTEES  
8 OF STATE INSTITUTIONS OF HIGHER LEARNING NEEDED TO FULLY FUND THE  
9 CRITICAL NEEDS TEACHER SCHOLARSHIP PROGRAM, FOR FISCAL YEAR 2001.
