**SUBSTITUTE 1 FOR AMENDMENT No. 1 PROPOSED TO**

**House Bill NO. 540**

**By Senator(s) Bryan**

1           AMEND by inserting the following after line 21 and renumber  
2 subsequent sections accordingly:

3           SECTION 2. Section 5-3-95, Mississippi Code of 1972, is  
4 amended as follows:

5           5-3-95. (1) The members of the committee shall be entitled  
6 to receive compensation for attending meetings as follows:

7           (a) Per diem compensation for each day engaged in the  
8 discharge of official duties at the same rate as compensated  
9 during a special session of the Legislature \* \* \* and  
10 reimbursement for all actual, necessary expenses incurred in the  
11 discharge of official duties, including mileage as authorized by  
12 law \* \* \*; or

13           (b) Per diem compensation in the amount authorized by  
14 Section 25-3-69 and a mileage allowance and an expense allowance  
15 in the amount authorized by Section 5-1-47.

16           (2) Prior to receiving any compensation pursuant to  
17 subsection (1) of this section, a member of the committee shall  
18 give notice in writing to the Secretary of the Senate or the Clerk  
19 of the House of Representatives, as the case may be, of the manner  
20 in which he desires to be compensated pursuant to subsection (1)

21 of this section.

22 (3) No compensation shall be paid pursuant to this section  
23 for attending meetings of the committee while the Legislature is  
24 in session.

25 SECTION 3. Section 5-3-125, Mississippi Code of 1972, is  
26 amended as follows:

27 5-3-125. (1) The members of the committee shall be entitled  
28 to receive compensation for attending meetings as follows:

29 (a) Per diem compensation for each day engaged in the  
30 discharge of official duties at the same rate as compensated  
31 during a special session of the Legislature \* \* \* and  
32 reimbursement for all actual, necessary expenses incurred in the  
33 discharge of official duties, including mileage as authorized by  
34 law \* \* \*; or

35 (b) Per diem compensation in the amount authorized by  
36 Section 25-3-69 and a mileage allowance and an expense allowance  
37 in the amount authorized by Section 5-1-47.

38 (2) Prior to receiving any compensation pursuant to  
39 subsection (1) of this section, a member of the committee shall  
40 give notice in writing to the Secretary of the Senate or the Clerk  
41 of the House of Representatives, as the case may be, of the manner  
42 in which he desires to be compensated pursuant to subsection (1)  
43 of this section.

44 (3) No compensation shall be paid pursuant to this section  
45 for attending meetings of the committee while the Legislature is  
46 in session.

47 **FURTHER, amend line 6 of the title by inserting the following**  
48 **after the semicolon:**

49 TO AMEND SECTIONS 5-3-95 AND 5-3-125, MISSISSIPPI CODE OF 1972, TO  
50 REMOVE THE PROVISION THAT PROHIBITS MEMBERS OF THE STANDING JOINT

51 LEGISLATIVE COMMITTEE ON REAPPORTIONMENT AND THE STANDING JOINT  
52 CONGRESSIONAL REDISTRICTING COMMITTEE FROM BEING PAID PER DIEM  
53 COMPENSATION AND REIMBURSEMENT FOR EXPENSES FOR MORE THAN 30  
54 CALENDAR DAYS AND TO REVISE THE COMPENSATION FOR ATTENDING  
55 MEETINGS OF SUCH COMMITTEES;
