## HOUSE BILL NO. 593

AN ACT TO AMEND SECTION 27-53-5, MISSISSIPPI CODE OF 1972, TO 1

AUTHORIZE, RATHER THAN REQUIRE, UTILITY COMPANIES TO FURNISH

INFORMATION IDENTIFYING THEIR CUSTOMERS WHO RESIDE IN MANUFACTURED AND MOBILE HOMES TO THE COUNTY TAX COLLECTOR; AND FOR RELATED 3 4

5 PURPOSES

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6

7 SECTION 1. Section 27-53-5, Mississippi Code of 1972, is

amended as follows: 8

9 27-53-5. (1) It shall be the duty of the owner of a

manufactured home or mobile home, not later than seven (7) days, 10

Saturdays, Sundays and legal holidays excluded, after the date of 11

purchase or entry into the county where the manufactured home or 12

mobile home is located, to register such manufactured home or 13

14 mobile home with the tax collector of the county where the

manufactured home or mobile home is located. If a certificate of 15

title has been issued or applied for concerning the manufactured 16

home or mobile home, the original certificate of title or a copy 17

of the application shall be presented to the tax collector at the 18

19 time of the registration. The registration application for such

manufactured home or mobile home shall contain the following 20

information: name and address of owner, length and width of the 21

22 manufactured home or mobile home, serial number of manufactured

home or mobile home, make of manufactured home or mobile home, 23

date of purchase, present market value, and address where 24

manufactured home or mobile home is located if other than the 25

address of the owner. At the time that an owner registers his 26

27 manufactured home or mobile home, and before a registration

certificate may be issued by the tax collector, the owner of the 28

manufactured home or mobile home shall pay a registration fee of 29 One Dollar (\$1.00) to the county tax collector and provide proof 30 of payment of the previous year's taxes unless the manufactured 31 32 home or mobile home was purchased from a licensed dealer. 33 also the duty of the owner of the manufactured home or mobile home to reregister his manufactured home or mobile home with the tax 34 collector within seven (7) days after the relocation of such 35 manufactured home or mobile home from one (1) location in the 36 county to another location in the county in order that there will 37 always be on file with the tax collector the current address of 38

such manufactured home or mobile home.

- It shall be the duty of every manufactured home or 40 mobile home owner to provide proof of registration in the county 41 in which the manufactured home or mobile home is located and at 42 the address at which utility service is to be provided, as 43 required by subsection (1), to each utility company whose service 44 is procured by the owner before the utility company shall connect 45 46 its services. For purposes of this section, "utility" shall mean and include water, gas, electric and telephone services, including 47 48 such utilities as are owned and operated by municipalities.
  - (3) No utility company shall connect, provide or transfer service without receiving and recording the number of the current registration certificate issue for the manufactured home or mobile home at the address where service will be connected, provided or transferred.
- (4) It shall be the duty of every manufactured home or mobile home owner subject to the use tax levy in Section 27-67-5 to provide proof of payment of such tax prior to the time of registration. If the manufactured home or mobile home has been registered in another county in this state, then the owner shall only need to show proof of such registration.
- (5) Every utility company, in its discretion, may furnish to
  the county tax collector, upon request, the names, addresses and

- 63 customers to whom the utility company provides a service.
- SECTION 2. This act shall take effect and be in force from
- 65 and after July 1, 2002.
