COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1484

AN ACT TO AMEND SECTION 49-17-25, MISSISSIPPI CODE OF 1972, TO REMOVE THE REQUIREMENT THAT THE COMMISSION ON ENVIRONMENTAL 3 QUALITY MUST HOLD A PUBLIC HEARING PRIOR TO THE ADOPTION, AMENDMENT OR REPEAL OF ITS REGULATIONS; TO REQUIRE THAT THE COMMISSION ON ENVIRONMENTAL QUALITY COMPLY WITH THE REQUIREMENTS OF THE ADMINISTRATIVE PROCEDURES LAW IN THE ADOPTION OR 7 MODIFICATION OF ITS REGULATIONS; TO REQUIRE THAT THE COMMISSION SHALL HOLD A PUBLIC HEARING ON ANY PROPOSED REGULATION IF THE 8 HEARING IS REQUESTED BY A CITIZEN OF MISSISSIPPI; AND FOR RELATED 9 10 PURPOSES. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 12 SECTION 1. Section 49-17-25, Mississippi Code of 1972, is amended as follows: 13 49-17-25. * * * 14 (1) * * * The adoption, amendment or repeal of any rule or 15 regulation by the commission under this chapter, Chapter 17 of 16 Title 17, Sections 21-27-201 through 21-27-221, Sections 37-138-1 17 through 37-138-29 and all other laws administered by the 18 department shall be governed by the "Mississippi Administrative 19 Procedures Law." Any rule or regulation * * * adopted, amended or 20 repealed in substantial compliance with the procedural 21 requirements under Section 25-43-7 shall be valid. * * * 22 23 (2) In addition to the requirements under the administrative 24 procedures law, the commission shall conduct a public hearing 25 26 prior to the adoption, modification or repeal of a rule or 27 regulation, if a public hearing on the proposed action is requested by a corporate or individual citizen of this state. The 28 commission shall conduct the public hearing after giving public 29

notice. The commission shall publish notice of the hearing by

publication once each week for three (3) successive weeks in a

- 32 newspaper having a general circulation throughout the state. The
- 33 notice shall describe the proposed regulation and the time, date
- 34 and place of the hearing. This notice also shall be posted on the
- 35 <u>commission's official Internet website for the same period.</u>
- 36 **SECTION 2.** This act shall take effect and be in force from
- 37 and after July 1, 2002.
